Manager's Report by Angie Webster



2023 has come to an end. Many improvements took place in the last half of 2023. Just to name a few... we repaired the deck at the clubhouse and made repairs at the beaches. Road projects and pothole repairs were completed for 2023. We have made substantial progress in removal of brush and overgrowth along roadways. The Dam rip rap project was also completed and the clubhouse sidewalk was replaced and the hand railings repaired and painted. If you are out and about and see something in need of attention, please report it to the office.

Dues and assessments were due January 1st. We do allow for three installments of \$270.00 due January 1st, March 1st and May 1st without penalties. Members who are experiencing financial difficulties or have special circumstances can call the office for additional assistance. Also, if you pay your bill in full by close of business February 14th you will be placed in the drawing for a chance to win your assessments (\$760) back.

If there is snow in the forecast, please refrain from parking vehicles, trailers, and such on the roadways. We will begin to plow after a 2" snow fall. Have patience with our maintenance crews as they work to get the roads clear. A list of priority roads is on page 23.

The office's 10th Annual Pet Food and Supplies drive wrapped up at the end of 2023. We want to thank everyone for the generous donations this year.

Boat Stickers for the 2024 season are now available in the office. 2024 D & A must be paid in full in order to get the 2024 stickers. Don't forget your watercraft registration if it has expired and proof of at least \$300K water craft liability insurance. 2023 decals are valid until April 30, 2024.

Keeping Us Out of the Fire

Is the God of the Bible just an impulsive, capricious fool who is really at fault for human sin and wrong? That view looks like this. God makes up a bunch of senseless rules like 'I don't like red shoes' and 'nobody shall wear them' and 'disobedient people who do will go to hell.' But then God loves the sinner so much that he kills his Son, Jesus, in his place taking his penalty so that the sinner doesn't have to die. What a stupid God, they say. If only He hadn't made that senseless rule in the first place....

But that doesn't at all picture what God has done. Rather, it's like this. You are out camping alone in a forested area. You build a fire one morning to enjoy bacon and eggs. You leave the campsite for a hike but fail to extinguish your campfire. A couple of hours later you look back toward your campsite and see fire along the tree tops and smoke pouring into the sky. You realize it is your fire, out of control. To your horror, you see that the wind is blowing the flames in your direction and it's coming fast! You can't outrun it. If things continue as they are, death is certain. And it will be horrible death. And it's all your fault.

You start to feel the heat from the flames. There is no way out. The fire you set is going to come back and kill you. Then someone appears, racing toward you. He is strong and young. He grabs you, wraps you in his own personal fireproof blanket and pushes you onto the ground. Finally the fire passes. The heat diminishes. It's over. You peek out of the blanket and see a body on the ground. Then it hits you, your rescuer gave his shield and his life so that you could be saved.

That's really the way it is. The sinful things we do in life, light a fire that eventually comes to destroy us. Jesus is the only One who can save us from the inferno of our sin. This he does at the cost of his own life. There is nothing stupid about this, just a demonstration of love and compassion.

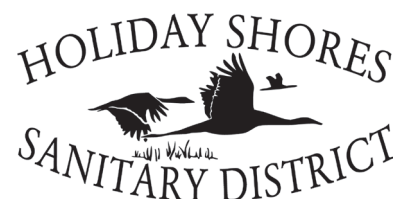

HSVFD Proposal for Incentivize Fire Department Membership and Participation
Tony Harris submitted questions and thoughts to the board about creating a new member class and wording to fall under "Rules and Membership". Conversation ensues. Jerry Theodore (1346), Bob Wheeler (1934), James Shepard (1641) shared their concerns for creating a new membership for the volunteer firefighters. Bob Wheeler (1934) shared information about Capital Credits that members have with Southwestern Electric. There was information in the November issue of The Southwestern. Conversation ensues with the HSVFD Proposal. Ty Van Ryswyk This needs to be talked about more before we hammer out the law per se and the verbiage of it. Because you could go to the fire department, and this is just one and I'm saying this is why we need to slow the roll and talk about it. But you could ask the fire department to incentivize their people that don't live out here. But I do want to feel safe and know that we have enough people on our fire department. And so without increasing the number of members, you can incentivize the members of Holiday Shores with this, not so much the people that don't live out here. Then you're getting rid of the increase of people or members, or the friend of a friend of a friend that doesn't belong here. All those things go to the wayside. We would just be asking for Holiday Shores members to get incentivized. The fire department can worry about incentivizing those that don't live out here. But again, that's just one scenario. I think there's a lot of them probably to be talked about. But that's, I guess to me, we should probably table this for further discussion and ask for members to come up here to get their opinion. Shaun Diltz I'm on the side of throwing it out. (There will be more discussion on this topic in the future.)

Fish Stocking Update

Shaun Diltz We had a fish delivery on October 30 that included 3,640 purebred striped bass that were 3-5" along with 5,700 2-3" hybrid that were delivered on the same truck. Freight for that was \$1,000. We were supposed to get another delivery on Monday but they pushed it back to Friday because some of the fish looked stressed out and they wanted to give them a few days to recover. What's going to be coming on Friday is 7,000 largemouth bass 5-7", 10,500 redear and 1,725 catfish 6-8". Shipping is \$1,500. You will be able to see the latest spreadsheet on the Holiday Shores website in a month or so. We're going to throw a couple 100 bass and a couple 100 redear into the North ponds. 500 bass, 300 catfish and 500 to 1000 redear into Su Twan. At our fishing meeting in July we talked about raising our bass limit from 14" to 15 or 16". The reason that we're going to

do that is the main reason would be when we have fishing tournaments, or when people are out fishing and they keep up to 14" bass, that could be a male that's guarding a nest during spawn so want to throw them back, let them guard their nest so those babies have a chance to live and reproduce. State biologists have been pushing to move all lengths up to 15" and the bass club is going to take a vote at their January meeting to raise it to 15 or 16" and then they're going to bring it back the board and then we will decide.

- 3 cloves garlic, peeled and chopped
- 1 can (15 1/2 ounces) cannellini beans, drained and rinsed

- 1 can (28 ounces) diced tomatoes
- 3 cans (14 1/2 ounces each) low-sodium chicken broth (about 6 cups)
- 1/2 teaspoon freshly ground black pepper
- 1/2 cup small pasta, such as ditalini, uncooked
- 2 cups frozen cut leaf spinach or chopped fresh spinach
- 2 jars (15 1/2 ounces each) Aunt Nellie's 3 Bean Salad, drained
- 1 tablespoon lemon zest (optional)

Preheat oven to 375 F. Place bread cubes in single layer on large baking pan. Bake until bread cubes are lightly browned, 8-12 minutes. Set aside.

What about trashcans on pick up days?

Trashcans & recycle containers must be 4' off the road.

The snowplow drivers will not get out to move your containers and will not be responsible for damage.

As soon as your 2024 Dues & Assessments are paid in full you can come into the office & pick up your 2024 decals.
2023 decals expire April 30, 2024.

Lot numbers and decals need to be present on ALL watercraft and slow moving vehicles.

This includes all non-motorized watercraft (kayaks, canoes, paddle-boards & paddle-boats). You must bring your current watercraft registration and proof of \$300,000 liability insurance on the watercraft to receive your motorized watercraft decal.

Non-highway Vehicle decals are \$15 annually.

The state requires driver to have a valid driver's license and proof of minimum liability insurance coverage be carried within the vehicle.

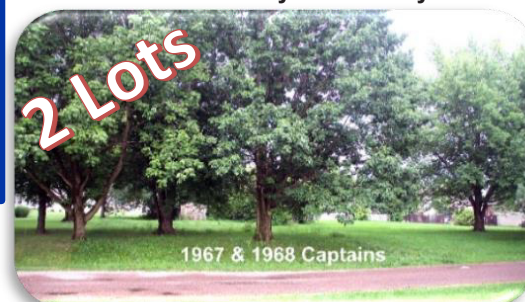

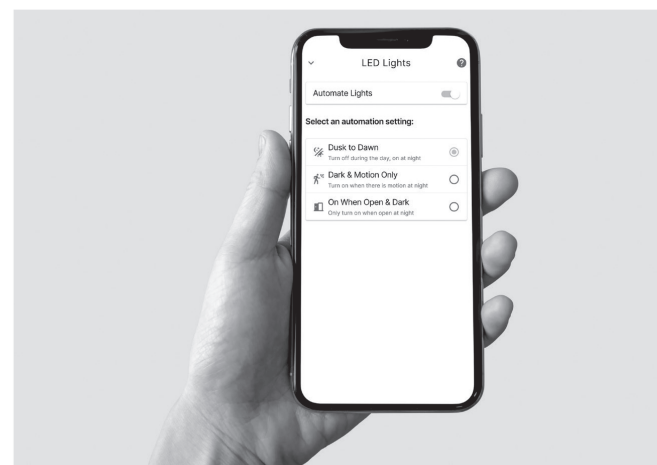

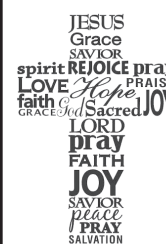
