BIG TRASH PICKUP - JUNE 12

Acceptable items included in large item pickups:

ACCEPTABLE BULK ITEMS

- Carpet: cut into bundles no longer than 4' in length and 3' in diameter and weighing less than 50 lbs. per bundle
- Furniture: couches, chairs, dressers, tables, desks, etc.
- Glass portions of doors/windows: must be broken down and placed into small box marked "glass".
- Mattress sets and box springs: (must be wrapped in plastic with ends wrapped/taped closed.)
- Appliances
- Basketball sets/poles, unless they are broken down into section! and no larger than 3' in diameter.



UNACCEPTABLE BULK ITEMS

- Batteries
- Concrete and construction material of any kind
- Electronic waste: televisions, computer monitors/accessories, Mp3 players, DVD/VCRs etc.
- Fluorescent light bulbs
- Lead/oil-based paint/varnish
- Loose trash or trash in cardboard boxes
- Tires
- Yard waste



Manager's Report by Angie Webster



I have seen many of you out on my travels throughout the community. I have been doing road inspections, visiting outlots, and looking at culverts and ditches. We will be starting pothole patches with the road plan and then moving on to other roads. We understand there are a ton of potholes right now, and we will get to them all. The tentative date for chip and seal is August 11th and August 12th. 2024 boat stickers expired April 30th. I have already issued 18 tickets for this infraction, that does not include what we wrote this weekend. Boats that have expired stickers (Holishor or State) that are in operation, tied to a dock or on a lift will be getting citations. Lot number and state numbers are also required on your boat. You must bring to the office your current registration and proof of \$300,000 watercraft liability and be paid in full to receive your 2025 decal. I would like to remind members while using the boat ramp at the Marina to please lock the gate after launching or removing your boat. This is an important step to help us keep non-members off the lake. Keys for the gate for members are available in the office for \$3.

One of the major complaints I have heard in the past month is kids on golf carts. Parents, please understand this is a safety issue, not only for your kids but for other members of the community. I have heard complaints about driving too fast, taking corners too fast, ignoring stop signs, too many people on the cart, and texting while driving. You must be 16 years of age, with a valid driver's license to operate on the roads.

We will be watching for solicitors and trespassers. We have already run off a few. I would like to mention that I do not monitor Facebook, Instagram, tiktok or any other social media. If you see something call the code enforcement number, if they are unavailable, call Madison County. Complaining on Social Media will get you nowhere.

Grass is growing at an alarming rate, and we have several members that have very tall grass on lots and yards. In addition to the grass, I have seen a lot of yard debris (mattresses, old building supplies, tires, and trash) Now that the weather has cleared up, let's work to get these issues taken care of. I also want to discourage people from throwing their branches and yard waste on empty lots that do not belong to you. One member has a huge brush pile on empty lot and has no trees or bushes on their lot.

April 9, 2025

Call to Order

John Crotty called the meeting to order at 7:34 p.m.

Board Members in Attendance: Jennifer Halverson, John Crotty, Ty Van Ryswyk, Tony Harris, Jim McCann, Trish Yates

Association Office Present: Angie Webster, Karla Suttles

Members Present:

Board Members Excused: Sarah Jacoby

Pledge of Allegiance recited.

Approval of Minutes

Tony Harris motioned to approve noted changes for the March 26, 2025, meeting minutes, **Trish Yates** seconded, all in favor, motion passed.

Transfers of Property

There was 1 transfer of property, which had an initiation fee. Membership is 1274.

Bills & Salaries

Tony Harris motioned to approve the bills & salaries, **Jim McCann** seconded, all in favor, motion passed.

Treasurer's Report

Profit & Loss Summary:

Jennifer Halverson: Asked if the overage for Property Insurance was correct and asked that we change Public Safety to Lake Patrol. **John Crotty:** Indicated that the Net Income is not zeroing out. **Jim McCann:** Indicated that we need to complete the journal entry for reserves. **Action: Angie will review the Profit & Loss items for correction.**

Treasurer's report: No questions presented.

Manager's Report & Code Enforcement Report

Angie Webster read the manager's report (which can be found published in full in the Holiday Times). **Jim McCann:** Noted the potholes and other damage to the roads from the excess rain. **Tony Harris:** Asked if the dip at Caribbean and St. James was corrected. **Angie Webster:** Confirmed that St. James & Caribbean was corrected and acknowledged the impact to the roads from the rain. **John Crotty** summarized the code enforcement report and noted recurring building violations and derelict vehicles. **Jim McCann:** Asked if Code Enforcement is checking on the builds as they go up. **Angie Webster:** As new builds pop up, they will verify they have a building permit, but are not checking during the build.

Old Business: None

New Business

HSBAR Variance (964) – Member was not aware of the pod rule limiting usage to 30 days. Pod was delivered on January 2. The remodel permit started on January 7 for a large remodel project. They are expecting to finish the project by the end of June. Requesting a variance to retain the pod on the property until the end of the project. **Sam Crumbacher (964):** Took over home from a trust and has a building permit for 6 months. The entire first floor is gutted and has nowhere to go with contents. **Jim McCann** motioned to approve the variance request for the POD, **Trish Yates** seconded, all in favor, motion passed. **Jennifer Halverson:** Noted that the CB&R Committee should review this rule.

HSBAR Variance (916) – Member is requesting solid gates on both sides of the house to ensure that the gate can only be unlocked from the inside. **Lexi Dona (916):** Reiterated the intent of the gate to prevent the dogs from escaping. Have had issues with the gates being left open by utility companies or others during the night. **Jim McCann:** Asked if full gates were included in the building permit. **Lexi Dona (916):** The solid gates were put in place after the building permit as a result of testing that they could unlock the gate from the outside. **Tony Harris:** Recommended putting a plate (or other material) or 2 boards on each side that blocks the lock. **Tony Harris** motioned to approve modification of the variance to allow for 2 solid boards (1 foot on each side) on each side of the lock, **Jim McCann** seconded, all in favor, motion passed.

HSBAR Variance (609) – New construction building permit submitted and approved with 100% brick on the house and 50% brick on the garage. Builder chose to use stone instead and did not obtain approval for the change and is now

asking for a variance. **John Crotty:** Asked to table the variance approval due to questions from the board for when the builder is available.

HSBAR Variance (606) - New construction building permit submitted and approved with 100% brick design on both the house and the garage. Builder chose to use stone instead and only applied it to 50%. Builder did not obtain approval for the change and is now asking for a variance. **John Crotty:** Asked that he stop construction until he aligns with the current permit or puts masonry as per our rules.

2025 Annual Meeting Member Packet Approval – Board was presented with sample copy of the packet. A summary page was added this year due to the number of ballots and changes. Each bylaw ballot has a summary of the change.

Tony Harris: Recommended that we put the change summary at the top of each ballot. **Jennifer Halverson:** Requested that page numbers be added to the bylaw ballots. Noted that ballot 3 had punctuation errors from accepting the marked-up changes. This will be corrected and sent to the office.

Draw for BOD Ballot Order – Ballot order will be Lexi Dona, Ben Kelley, and then Tony Harris.

Correspondence

Holiday Shores Ski Club – Requesting use of the lake and property at the north end of the lake for show practices and shows between May 1 through October 31. Docks will be in the lake from April through November 1. Anchor the ski jump in the north end no wake area with the option to pull it out and temporary anchor for practices. Lake Patrol assistance on July 2 from 6-830 pm for rehearsal and on July 4 from noon – 3pm. Host the Missouri Disabled Water Ski Association event on September 6, 2025, from 7am-5pm. **Ty Van Ryswyk:** Since this is a draw down year, equipment will need to be removed in September. **Jennifer Halverson:** Requested that the Ski Club submit a variance to allow associate members to join, as current rules specifically exclude them from participating. **Ben Kelley (1824):** Asked if this is applicable to other committees and clubs. **Jim McCann:** Confirmed that this only applies to the Ski Club as the rule was specifically added at the Ski Club's request. **Ben Kelley (1824):** Requested confirmation that no other rules apply to other clubs and committees. **Jennifer Halverson:** Read the rule under Associate Member on page 32 of the CB&R. Which states: This class of membership does not retain any rights or privileges to: Be a member of the Ski Club. Page 35: Participation in the Ski Club will be limited to Association Members only. Page 12: Notwithstanding the foregoing, tenant members shall be allowed to serve as members of the Social Committee, the Ski Club, the Garden Club, the Fishing Committee, and such other clubs or committees as the Board of Directors may from time to time provide. **Ben Kelley (1824):** Indicated that he sent a correspondence to the office in July that was moved to committee review but was never acted upon. **Jim McCann:** It was confirmed that only associate members who were previously part of the Ski Club are allowed to participate, excluding any current associate members who have not been members in the past. **Ben Kelley (1824):** Disagreed with this statement. Noted resource limitations in allowing everyone to join the Ski Club. Specifically noted being able to support beginners. Asked for the request to amend the rule to be reviewed. **Dave Decker (1184):** Ben stated that due to limited resources, he could not support opening the Ski Club to all associate members. This reasoning aligned with the original request from the Ski Club to restrict participation, which the Board supported. For this same reason, the committee denied the request to change the rule and allow associate members to join. **Ben Kelley (1824):** The club acknowledged limited resources to support beginner skiers but confirmed that any associate member who is not a beginner is welcome to join. **Tony Harris** motioned to approve request with noted change to remove equipment by September 10 due to it being a draw down year, **Jim McCann** seconded, all in favor, motion passed.

Action Summary

Prior Actions: Angie to determine if we have original plans from the 319 grant to determine the depth of the retention ponds. **Update: Will have an update for the next meeting.** Angie to riprap the south side of the pond to address the breach **Update: Waiting for the rain to stop.** Angie to obtain bids to clean the restaurant and proceed forward. **She reached out to with no response. Dan Corey will continue to reach out and obtain additional bids.**

New Actions

Angie to review the Profit & Loss statement for the following: Property insurance cost, net income, journal entry for reserves, and change public safety to lake patrol. Revisions will be reviewed in May. Jennifer to send punctuation changes for ballot 3 to Karla.

Open Forum

The following items were discussed:

Ben Kelley (1824): Cited the following rule on page 35: Only members in good standing and their guests are allowed to use Holishor Association facilities. Nonmembers of the Association may not be members of any organization which use Association facilities. Asked if we are verifying participation in other clubs and committees. **Tony Harris:** Noted that Associated Members are members and reiterated that the rule was specific to the Ski Club in exclusion of associate members. **Jennifer Halverson:** Noted that in May the board will review an official document on Club and Committee Governance. **Dan Corey (978):** A resident with 27 years of experience in the food industry and certification as a master technician volunteered to assist with evaluating the restaurant kitchen equipment and supervising cleanup. He was informed that liability insurance may be required and is requesting Board approval to assist, offering to sign a waiver if necessary.

Angie Webster: Confirmed that the committee members were formally approved by the Board, and as an extension of the Board, they should be covered under the Association's general liability and umbrella policy. **Ben Kelley (1824):** Asked how to manage the fluid nature of Ski Club membership and whether a new variance would be required each time an associate member joins. He expressed a desire to follow proper procedures. **Ty Van Ryswyk:** responded that individual variances are not necessary for each member. Instead, the Ski Club should submit a general variance request to allow associate members, with any limitations—such as age or skill level—clearly outlined in that request. **Tony Harris:** Clarified that the club should determine how many beginner skiers they can support, give priority to full members, and then allow associate members as space permits. He noted it is the Ski Club's responsibility to verify associate member cards. **Dave Decker (1184):** Confirmed there is no age requirement for associate member cards; they can be issued to individuals of any age.

Adjournment: Motion to adjourn was made by **Tony Harris, Ty Van Ryswyk** seconded, all in favor at 8:27 p.m.

John Crotty called the meeting to order at 7:35 p.m.

Pledge of Allegiance recited.

Approval of Minutes

Tony Harris *motioned* to approve the April 9, 2025 meeting minutes, **Jim McCann** seconded, all in favor, motion passed.

Transfers of Property

There were 2 transfers of property, both with initiation fees. Membership is 1274.

Old Business

Restaurant Committee Update – The Restaurant Committee is in the early stages of gathering information. Work is underway to combine the lease agreements for the Beacon Inn and the Foundry. The committee is reviewing equipment needs and obtaining bids for cleaning and inspecting the equipment. They also plan to make unannounced visits to restaurants operated by prospective tenants to observe their operations firsthand. An application form will be developed, which will request financial statements, a resume of the applicant's background, and information about any current restaurant operations to assist with the review process.

North Property Fence Bids - The Board reviewed four bids for fencing along the north property to help keep vehicles off the lakeside and maintain a cleaner, nicer appearance. A split rail cedar fence is proposed for the top of the property

along the driveway, and either a split rail or chain link fence is being considered for the bottom of the dam. **Trish Yates:** Preferred the more aesthetically pleasing split rail fence, noting that the Association has the workforce and ability to maintain it. Emphasized that ongoing damage from trespassing and rule violations has led to repeated repair costs, including repairs to the dam. Suggested that making a one-time investment in fencing would help prevent further damage and save money in the long run. **Tony Harris:** Emphasized that the fences are necessary due to members damaging the property. Noted that the discussion included installing a fence only at the top of the dam and using signs at the bottom to keep vehicles off the area. Mentioned that if members do not follow the posted rules, the area could be closed, or additional funds would be needed later to install a fence. Acknowledged that it is unfortunate to spend money for this reason but stressed the importance of protecting the property. **Ty Van Ryswyk:** Pointed out that contractors may have based their bids on completing both fencing projects together, and separating the work could lead to higher costs later. Advised that delaying the second fence could result in paying more in the future. **Ty Van Ryswyk** *motioned* to approve the DNR Fence proposal for split rail fencing at both the top and bottom locations for a total cost of \$10,295, **Trish Yates** seconded, all in favor, motion passed. Bid details:

DNR Fence: \$10,295 for split rail on both sections; \$11,207 for split rail up top and chain link at the bottom.

Williams Fence: \$11,680 for split rail on both; \$12,030 for split rail up top and chain link at the bottom (includes a \$350 additional charge).

Collins & Herman: \$17,250 for all split rail; \$17,995 for black vinyl chain link at the bottom.

Superior Fence: \$11,942 for all split rail; \$12,159 for chain link.

Culvert / Ditch Repairs:

Acapulco / Holiday Point Parkway: Three bids for repairing the ditch: Pro Excavating for \$7,560, C&H Grading and Excavating for \$18,447, and Stutz Excavating for \$25,900. **Angie Webster:** Explained that the ditch on Acapulco is severely eroded, with a zigzag shape and many roots interfering with drainage. The plan is to backfill and reshape the ditch to improve water flow, dig it deeper at the bottom to slow runoff, and then riprap and seed the area. Noted that a pine tree on a neighboring property has extensive roots in the ditch; permission has been granted to remove the tree if necessary, and appropriate documentation will be signed by the member.

Shore Drive (behind Behme's): It was noted that erosion in the ditch area is getting worse, with parts of it wearing away right up to the road and starting to go underneath it. Bids for the repair work were received from Pro Excavating for \$16,090, C&H Grading and Excavating for \$25,340, and Stutz Excavating for \$40,800.

Biscay Culvert (near Brittany Ct): This will be a four-step process: replacing the eroded culvert across Brittany, installing a tie-in box, tying in the culvert under Biscay, and connecting it to the pipe that leads to the lake. The previous culvert replacement had no clear outlet, and erosion has caused a sinkhole to form near Brittany. Completing the full project at once will ensure proper drainage. Bids received were: Pro Excavating for \$20,070, C&H Grading and Excavating for \$32,296, and Stutz Excavating for \$32,600. **Angie Webster:** Noted that there should be a pipe in place already and the bid would go down if they dig and find the pipe. **Jim McCann:** Asked why an 18-inch culvert would not be used consistently throughout the project instead of switching from a 15-inch to an 18-inch size. **Angie Webster:** Explained that the culvert under Brittany is currently a 12-inch pipe, but an 18-inch pipe could be used instead, and she already has a piece of 18-inch pipe available that could potentially reduce costs. She noted that pipes in the area are buried, making it difficult to measure accurately, and the pipe running to the lake is a 30-inch pipe. The project involves tying the Brittany and Biscay culverts together to properly direct drainage to the lake. **Tony Harris:** Asked whether it made sense to install a larger pipe, noting that if all water is draining to this low spot and two culverts are being combined, using an 18-inch pipe would be more appropriate to handle the volume. **Angie Webster:** Stated that she could have the project rebid with the larger pipe size, and she does not expect the change to significantly impact the overall project cost. Conclusion state-

ments: **Ray Garber (1822):** Awarding all three projects to the same contractor without prior experience should only be considered if there are significant cost savings. **Angie Webster:** Clarified that each project was bid separately and there is no current indication of additional savings for awarding all three together. Noted that although she has not worked with Pro Excavating before, all the feedback she has received about them has been positive. The suggested project priority is: first, Biscay to properly direct water flow; second, the Shore Drive project; and third, Acapulco. **Tony Harris:** Noted that funding for the projects would come from the culvert reserves. **Ty Van Ryswyk** motioned to approve the Pro Excavating bids for Projects One (Acapulco), Two (Shore Drive), and Three (Biscay), with the motion based on the current bid amounts, **Jim McCann** seconded, all in favor, motion passed.

Sediment Removal - Ty Van Ryswyk: provided an update on the sediment removal project, noting that SES (Soil Erosion Specialists) submitted the lowest bid. A follow-up meeting was held with the contractor, John, and Mr. Engelke to confirm agreement on the dump sites and project scope. All parties present were comfortable with moving forward based on the agreed specifications for both scopes of work. **Ty Van Ryswyk** motioned to accept the SES bid for sediment removal, covering both Scope One and Scope Two at the north end of the lake, with work to occur later this year during the lake drawdown, **Trish Yates** seconded, all in favor, motion passed. **Ty Van Ryswyk:** Noted that we do need to engage a drone company. **Tony Harris:** noted that both scopes of work were \$408,500.

New Business

POD Variance Request (7156) - A request was submitted for a storage pod at 7156 St. James Drive due to a home renovation project. The renovation is expected to exceed the standard time allowed for storage pods, and the requester is asking for an extension through June 30. **Tony Harris** motioned to approve the variance request for the POD, **Trish Yates** seconded, all in favor, motion passed. **HSBAR Variance (609 & 606)** - Both properties were approved with building permits showing 100% brick on the front elevations, with 609 allowing 50% brick on the garage. The builder unilaterally changed the material to stone and applied it only halfway up the front, with siding above, without prior approval. A variance is now being requested for both homes. The Building Committee does not support the variance. The builder was unable to attend the last Board meeting and was advised to pause construction or comply with the approved masonry requirements. However, the builder proceeded with the work, and both homes are now finished with stone on the lower half and siding above. **Tony Harris** commented that the partial brick approval on 609 may have been a lapse on the part of the Building Committee and should not have been approved as submitted. He stated that while stone may meet the masonry requirement, it must be applied to the full height of the first story per the rules. He opposed the variance for both 606 and 609, emphasizing that the builder should be held responsible for correcting the non-compliant work, even if the homes have already been sold. **John Crotty:** The variance fails due to lack of motion.

Ski Club Variance - Submitted a variance request for membership to which the board has additional questions. **Tony Harris:** It was noted that the Ski Club is seeking a variance to allow associate members to join for the 2025 calendar year. References to legacy memberships and adult children were listed, but since those terms are not defined in the rules, it was suggested to simplify the request to focus solely on allowing associate members. Noted that membership can be first come first served and have a quota. **Ben Kelley (1824):** The intent of the variance request is to align with how the Ski Club has been operating for the past 18 years. Noted that the main challenge for the Ski Club is accommodating beginners, as there are limited resources to support a large number of new skiers. **Trish Yates:** The way the variance is currently written is discriminatory by trying to include some members while excluding others. Associate members should either be allowed or not allowed. **John Crotty:** Explained that the only existing rule is that associate members are not allowed to be part of the Ski Club. Therefore, the only variance the Board can offer is to allow associate members. **Tony Harris:** Proposed that the variance request be revised to simply state that the Ski Club would like to request a variance for the 2025 calendar year to allow associate members to be members. He recommended approving the variance based on the revised

language to avoid needing to revisit the issue again. **Ben Kelley (1824):** Noted that the Ski Club is scheduled to begin activities on May 1 and would like to move forward with the proposed language. He stated that, based on last year's numbers, seven individuals (three children and four adults) would have been covered by the proposed variance. He also mentioned that the Ski Club currently has a total of 40 members. **Jim McCann:** Advised the Ski Club to review its bylaws regarding legacy memberships to ensure they do not expose the Association to potential discrimination issues. He referenced recent changes in Illinois laws, including the Fair Housing Act and CICA, and expressed concern that allowing selective membership could put the Association at risk if challenged. **Tony Harris** motioned to approve the variance request for the Ski Club to allow associate members to be members for the 2025 calendar year, **Trish Yates** seconded, all in favor, motion passed.

Finance Q1 Update - Tony Harris: Reported that the Finance Committee reviewed the actuals against the budget and confirmed that, as of the first quarter, the Association is on track to meet its budget goals.

Correspondence

546 - The owners of 546 Overlook submitted a concern regarding a neighbor's broken tree hanging over their fence. They noted the tree continues to deteriorate after storms, posing a risk to their fence and personal safety. As a result, they are not allowing their children to play in the backyard. After unsuccessful attempts to resolve the issue directly with the neighbor, they are requesting the Association's assistance in deeming the tree a hazard. **Tony Harris:** Stated that the tree appears to be a hazard based on the photo and recommended deeming the tree or limbs a hazard under the Association's rules. He added that if the tree is dead, the entire tree should be removed, though it is unclear from the photo whether the tree is still living. **Angie Webster:** Confirmed that the tree is budding. Once a tree is deemed a hazard, the property owner has 30 days to remove it. 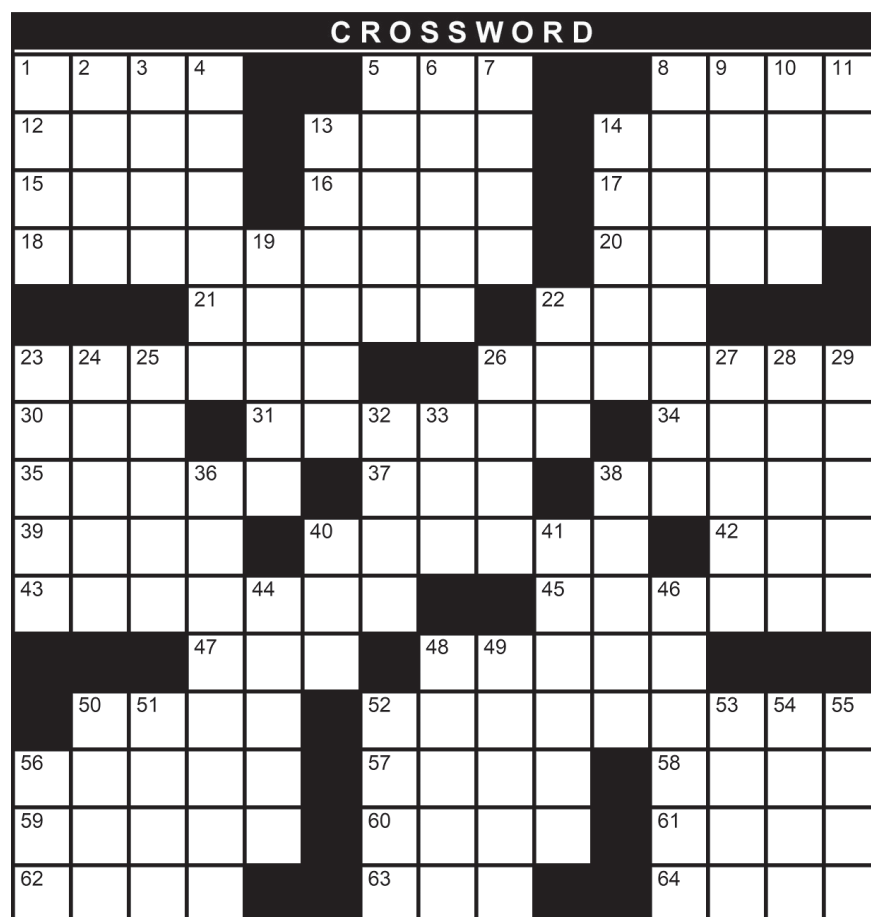

BEACH AND SWIM SAFETY

Holiday Shores Regulations

1. Beaches located within the Association are restricted to members, associate members and their guests only.
2. Glass bottles, fires, pets and food are prohibited from the beach area.
3. Persons under the age of 16 must be accompanied by a responsible adult 16 years of age or older.
4. Holishor Association Inc. is not responsible for one's personal items, nor any personal injury sustained while using Association facilities. (water, beach, grounds, etc.)
5. No swimming from sunset to sunrise in swimming area.

IL Dept. of Public Health Regulations

1. Beach water is not intended, nor fit, for human consumption. Do not swallow beach water.
2. Beach admittance may be denied to individuals having:
 - Contagious diseases
 - Infections (foot infections, ear infections, vomiting, diarrhea, inflamed eyes, unhealed abrasions or lacerations, skin lesions, or bandages of any kind.
3. Persons under the influence of alcohol or behaving erratically will be denied access/removed from the beach.
4. No food, drink, gum or tobacco products are permitted in the swim area.
5. The use of glass containers is strictly prohibited.
6. Children who are not toilet trained must wear tight fitting plasticized/rubber swim pants.
7. Swimming alone is discouraged.
8. Diving in shallow water is prohibited.
9. Personal conduct that endangers the safety of ones' self, or other beach patrons, is strictly prohibited.
10. Swimming is permitted between sunrise and sunset, except during the times of thunder and/or lightening. Swimmers are required to exit the water during these conditions and remain out for a minimum of 30 minutes following the last detection of thunder or lightning.
11. Pets are prohibited from the beach area.
12. Beach patrons are not permitted to feed local wildlife or entice them to stay in the area. Wildlife harassment is also strictly prohibited.
13. Measures taken to protect ones' self from the sun, such as sunblock, beach umbrellas, etc. are strongly recommended.

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.

- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.



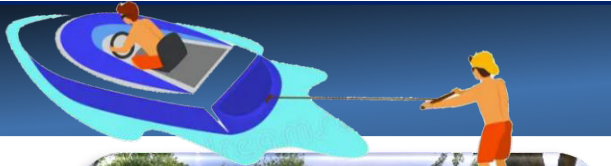
