Tony Harris – It is a requirement for the Board of Directors to review the budget on quarterly basis to see how we are doing as far as actuals to budget. I have reviewed the profit and loss and we are on track. There are a few variances here and there but nothing major.

Ditching Project Update

Dave Decker – I see there is a proposal to move one of the culverts.

Rob Clarkson – We ran into issue regarding a gas main and a force main for the sewer. The Sanitary District could only tell us it was on that side of the street because they have no idea where it was, but we found it without breaking it. It changed the elevation of the project by three feet in order to get underneath these. Rob Frey and I met with the engineer to come up with an alternative plan that our guys can actually do to alleviate that large hole in the photo I had provided. It has been referred to as a Southeast swimming pool by the size of it, which we will cut that in half. We will have to remove the culvert pipe that was installed and move it one lot to the North, that is where we will gain the three feet. Water will drain onto our lot at that time between Dolly and someone else, which will eliminate a possible issue.

Dave Decker – What does the Board want to do?

Matt Ressler – I'm fine with it.

Dave Decker – Does the Board want to approve it?

Anthony Harrell – Yes, this is a much better option.

Tony Harris – What did we do with the dirt that we dug out of the ditch?

Rob Clarkson – It's all on the North end. The only thing we did not keep is the concrete and asphalt. We will offer the dirt to the membership when this is all done.

Tony Harris – What is the time frame to remove that culvert and fill the ditch back in?

Rob Clarkson – I'm going to let them finish the work, I would say two to three weeks.

Matt Ressler – Motions to approve the change in the ditching project as submitted.

All in Favor.

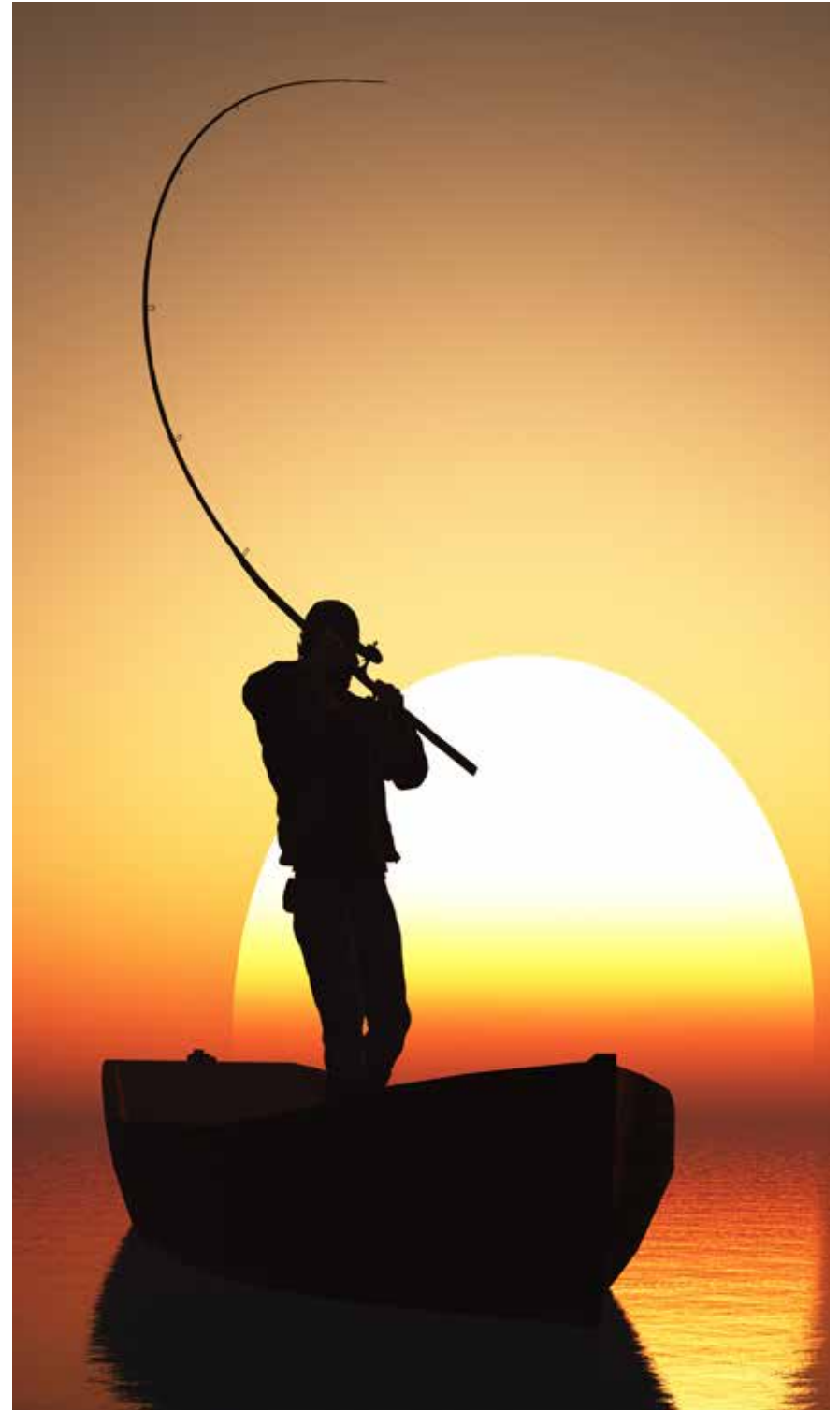
Manager's Report *by Rob Clarkson*

The Lake remains at full pool and our water quality is excellent. The busiest Holiday for our lake is quickly approaching. As we all head out to watch the fireworks on the lake let's be sure we have gone thru all the lighting on our watercraft. Navigation and anchor light are required after sunset by state law. Docking lights are only permitted to be used when docking not when traveling on the waterway. These bright lights make it difficult or even impossible to see the navigation lights of your vessel and create a dangerous environment for all when used incorrectly.

Over the Memorial Day weekend, I spent some time on the water and was taken back by the amount of expired boat stickers, wrong way drivers, and young children operating PWC's. New to the Boating Rules this season is a Mandatory Boating test for those under 16 years of age. Public safety will be checking against our records when they see this younger crowd operating boats or PWC's. Keep in mind the Member will also need to take this test if and when there is a violation issued. This test is a basic knowledge of boating rules pertaining to the Boating Rules of Holiday Shores and some state regulations. Members that allow their guests to operate any watercraft are responsible for their guests actions and for ensuring the guest knows all rules.

The Maintenance Dept has started on road repairs and completing the ditching project. Be careful when you see the flashing lights on the roadway, give them room and help us keep them safe. The roads on the 2020 road plan will be worked first then the remaining roads will be addressed. We are targeting mid-July to mid-August to complete the Oil and Chip portion of our 2020 plan.

Fence, Shed, Pool or perhaps a new home in your future? Don't forget your building permit. Building committee meets every 1st and 3rd Tuesday of the month to approve your plans. Drop off plans early and attend the meeting to avoid any delays. Board of Directors meetings are held 2nd and 4th Wednesday of the month at 7:30 pm in the clubhouse ballroom

If you can not wait to be the first on the lake with your 2020 boating decal, bring in to the office a copy of your registration and proof of \$300,000 liability insurance as soon as your Dues & Assessments are paid in full. There will be three types of decals, motorized, non-motorized and PWC.

Motion Carries.**Graduation Signs**

Dave Decker – This is something I have thought about over the weekend, technically they are against our rules. I would like to recommend the Board to approve a variance for those for a period of time, I would consider the end of June.

Shaun Diltz – I totally agree. I thought of that when my daughter was student of the month and I had seen those signs out here. I was wondering if we should do something similar with graduation.

Rob Clarkson – We approved those.

Matt Ressler – Motions to allow graduation signs in the community until July 1, 2020.

Shaun Diltz – Seconds.

All in Favor.**Motion Carries.****Community Wide Yard Sale**

Dave Decker – We have our annual yard sale that is scheduled for the first weekend in June. I know the office has been receiving questions whether or not it is still going to occur. My question is whether or not the Association wants to sponsor that by saying it's approved or take the stance that in our opinion that it shouldn't occur.

Anthony Harrell – I would say based on the vote Madison County took yesterday, it falls within the timeframe of Phase 2, which allows gatherings up to fifty people. I say we allow it.

Tony Harris – The problem is Madison County is fighting with the state over that.

Anthony Harrell – Is that our issue?

Matt Ressler – It can be.

Shaun Diltz – If we sponsor or not sponsor the event.

Dave Decker – I think we need to take a stance one way or another. They are calling the office asking whether or not we are having it.

Matt Ressler – I say for safety reasons that we postpone it until September or October. You have people coming from out of state and other locations. There's a possibility of bringing the virus into the community and we do not want that. My recommendation would be having it later this year.

Tony Harris – I would suggest September, because it will still be warm. If we are going to sponsor the yard sale, that is what I would do. Members could have their own if they chose. I suggest September 12, 2020. That is the weekend after Labor Day.

Dave Decker – In regard to Madison County's vote, there are cities within the county that are saying they are not going along with Madison County's decision due to liability.

Shaun Diltz – Unfortunately, everyone has been cooped up at home the last few months, this could potentially be our biggest yard sale if we did have it. Like Matt said, we would have people from all over which is kind of scary. Personally, I would advise they keep it at their own residence.

Dave Decker – My thought to that regard is as far as the Association is concerned, we are not having our community yard sale on June 6th. I advise we move it to September 12, 2020.

Matt Ressler – Motions to postpone the official Holiday Shores Annual Community Yard Sale to September 12, 2020.

Tony Harris – Seconds.

All in Favor.**Motion Carries.****Beaches**

Rob Clarkson – Our beaches open Memorial Day weekend. Normally, we would have opened the bathrooms a week ago, but I did not do that. We have closed signs on the beaches and a lifeguard staff ready to go. The main beach sign says swim at your own risk.

Dave Decker – Based on state, we can't, in my opinion. We follow state guidelines.

Rob Clarkson – What do I do if we have people on the beach? On the day it was 85 degrees, it looked like Forth of July out here.

Dave Decker – If it is state law that the beaches be closed, then the beaches need to be closed. That is just my opinion. No volleyball or anything.

Rob Clarkson – The state also says two people per boat. Are we an enforcing agent? That's the sticky area with me.

Dave Decker – We are responsible for the beaches, so I think that is different than the boats. From a state perspective, the rule is two per boat. We don't have an authorization to write state fines. We are responsible for the beaches. I just know in our society if something were to happen, they are going to come after us. It is our responsibility as the Board to protect the Association.

Matt Ressler – I agree.

Shaun Diltz – If I wanted to go swimming in the wintertime, I would. Even if the beaches are not open. I'm just thinking from a liable perspective on the different scenarios with not having a lifeguard there saying it's closed but letting them be there is worse than opening it with a lifeguard there and mandating social distancing. I know that goes against state order.

Dave Decker – My opinion is they need to be posted as closed and if we have a volleyball net, we need to take it down. If we see people there, we need to tell them that beaches are closed, and they shouldn't be there.

Tony Harris – You're going to have to or close the beaches. I don't mind people going to swim but we don't want the liability. If they are swimming off of their own property or boat, they are allowed to. I think if they want to use the tennis courts, they are welcome to do so as long as they have ten people or less and practice social distancing.

Shaun Diltz – There's only ten people in a true volleyball game too. I disagree with all of it.

Dave Decker – I'm not saying I agree with what has been decreed either.

Shaun Diltz – I understand that. I 100% disagree with running kids off of the beach.

Dave Decker – Nobody likes this.

Rob Clarkson – I will put closed signs out on all of the beaches and not worry about the tennis courts.

Matt Ressler – I recommend we contact council and our insurance to see if they would cover us with us allowing the beaches to be open. We can revisit this next meeting to discuss what they say. Until then, the beaches are closed.

Anthony Harrell – Motions to keep the beaches closed with no activity until we get council from attorneys and the insurance company on whether we should open them or not.

Matt Ressler – Seconds.

In Favor – Matt Ressler, Anthony Harrell and Tony Harris

Opposed – Shaun Diltz

Motion Carries.

Anthony Harrell - Motions to adjourn to Executive Session.

Rob Clarkson – Stutz is about 85% finished with their portion of the work. We had started gathering materials today to do our portion. With weather permitting, I'd say three weeks and we will be completely done with the ditching and will then be working on roads primarily.

Tony Harris – Sounds good.

Beaches Remain Closed

Rob Clarkson – In the last Board meeting, I was tasked to find out where we would stand on opening our beaches. I had contacted the insurance carrier first and received the response I needed. According to the Governor's Executive Order, all beaches and pools are to remain closed. The Health Department in our area will also confirm this Executive Order. Also, if an entity defies this order and opens up to the public, the liability insurance could be null and void due to not following state guidelines or orders. We left our signs up stating that our beaches are closed.

Tony Harris – Based on that feedback, we have to keep them closed.

Rob Clarkson – Looking into the phases, Phase IV allows for groups of fifty people or less. That is when the beaches fall into it. The earliest would be around mid-June and realistically, the end of June because Phase III is twenty-eight days, which starts on Friday. If the numbers are going in the right direction, it could end before twenty-eight days. The best-case scenario is mid-June.

Tony Harris – With the motion that was made last meeting of keeping the beaches closed until we hear from our insurance carrier, it sounds like we need to keep them closed pending moving to Phase IV. When we meet the second meeting in June, we can take a look at where we are based on the status from the Governor. We also have to discuss opening the beaches at fifty people or less and how we would monitor that.

Rob Clarkson – The only real problem we would have with that is on the Forth of July. It honestly wouldn't matter if the beaches are open or not. If we go forward with our Fourth of July, there is going to be more than fifty people out here.

Matt Ressler – What are we going forward with?

Rob Clarkson – As of right now, we have not cancelled our fireworks show. We applied for our firework permit and everything. If we cancel our show, that permit is still good for the later show.

Tony Harris – Pending on how this goes, we might have to push it off.

Rob Clarkson – The city of Edwardsville called me and their show is still on. Alton, St. Louis, St. Charles, everybody has cancelled.

Matt Ressler – If everyone else has cancelled, we are going to have a ton of people out here.

Dan Hopkins – What we should do is put up roadblocks and the members who live here can enter and the others be charged.

Matt Ressler – Members will have their families out here too.

Rob Clarkson – The majority of people will be on the water, but the beach is definitely crowded.

Matt Ressler – It's a packed house.

Tony Harris – We are going to have to give this a lot of thought.

Matt Ressler – We cannot charge people who do not live out here.

Rob Clarkson – The ski show is cancelled, which alleviates the daytime traffic.

Jerry Allen – Motions to keep the beaches closed until the second meeting in June.

Dan Hopkins – Seconds.

All in Favor.

Motion Carries.

New Business

Variance Request for Culvert, 1760 Fountainbleu

Tony Harris – We have a recommendation from the Building Committee stating they recommend this variance due to the elevation not allowing drainage. The homeowner would be responsible for culvert if ditching happens in the future. That is pretty standard when granting a variance. Does anyone have any questions on this variance?

Matt Ressler – Motions to approve this variance.

Dan Hopkins – Seconds.

All in Favor.

Correspondence for Sign at the Launch Ramp

Tony Harris – Didn't we used to have a sign there?

Rob Clarkson – Yes.

Tony Harris – This request is to put a sign back where the no wake line is for the water. The Tiki Bar Bass Club is offering to provide half of the initial cost of the sign of \$200 if the Board approves the sign. The future replacement of the sign will be the responsibility of the Association. The size of the sign is 24" by 36". Do we know the size of the previous sign? Out of curiosity.

Rob Clarkson – It would have been pretty close to that.

Jerry Allen – What is the total price of the sign? I know you said the Tiki Bar Bass Club would cover half.

Rob Clarkson – I wouldn't think it would exceed \$100. We will get the vinyl letters put on.

Matt Ressler – I think the vinyl would wear over time with the sun on it.

Rob Clarkson – Yes, but it's easier to replace. It is peel and stick.

Tony Harris – How would it hold up under the water? Could we reach out to the individual who is replacing our signs at the main gate?

Matt Ressler – That's what I was thinking. The replacement signs at the main gate are being powder coated.

Tony Harris – Rob, do you still have their contact information?

Rob Clarkson – Yes.

Tony Harris – I say we get a quote from him for a powder coated sign.

Matt Ressler – There used to be a sign at the north end also.

Rob Clarkson – I can't say I've ever seen it. We could put signage at a few places.

Matt Ressler – What would it cost to put a no wake light on the north end and the dam, and then synchronize them together? We have the technology nowadays.

Rob Clarkson – There is a reason our lights are set for dusk or dawn at the dam. You would run into a problem when it rains, the light on the dam does not come on. The official light is here at the clubhouse.

Tony Harris – I guess it is something to look at. **John Crotty** – Where would we place it on the north end?

Matt Ressler – Ski Beach. I advise getting a hold of Southwest Electric to see if they have a scrap pole that we could put up there. Then synchronize them together.

Tony Harris – If we could get that to work, I don't see a problem with changing the rule to reflect that.



2020 HOLIDAY SHORES POKER RUN

With much disappointment, Kevin and I have decided to cancel our poker run this year due to the state regulations on groups/gatherings set up for Covid-19. We appreciate all the support the Holiday Shores family have given this event over the years.



The Tiki Bar Bass Club spend the morning of May 30 putting fish habitat in the lake. We have been working with the board and IDNR fish biologist Fred Cronin and a fish biologist for the Arkansas Fish & Game. We wanted to make sure we built the habitat correctly since it will last for 50 years or more. All the fish habitat that was in the lake when it was built deep water and relax and get healthy after the spawn. You don't have to worry about hitting the habitat with a boat or while skiing, it's all in 12ft to 25ft of water. These habitat areas will be a great place to catch fish all year long. Within 15 minutes of dropping the habitat there were already crappie and sunfish on it. When we get finished placing all the habitat there will be a public map available at the office. We had a lot of help with donations from some local construction companies on the PVC piping, other than that the bass club funded the entire project. Big thanks goes out to Matt Ressler, Jason Lowry, Mark Dowdy and to all the bass club members and crappie fishermen that put their time in on this project.

Garden Tips for July:

- If annuals in your flower garden look scraggly and tired, cut them back by one-third or more. New growth will emerge in time for a late summer flower show.
- Watch for powdery mildew which usually appears in late summer. Fungicidal sprays can be applied to susceptible plants before it attacks.

Dan Hopkins – A problem we have had fishing, the no wake light did not come on until quarter after nine. This was just a few weeks ago.

Rob Clarkson – The water was coming up.

Tony Harris – I do like the idea. Rob will get us quotes on the sign and synchronized no wake lights. I'll then review the budget.

Open Floor

Matt Ressler – I have a letter from Shaun Diltz, who is chairman of the Fishing Committee. We have the fish structure approved to put into the lake last year. Where we are at now is some of the locations, the water is not deep enough to drop. Rob and I went out yesterday and checked some of these locations to confirm that the water is not deep enough. It may be deep enough, but it is not safe to put it there. In doing so, we checked some other locations and would like to remove two and add five more locations to this that would be suitable as far as depth goes for our lake. It will help our fish habitat tremendously. These areas that we are wanting to add, the water is deep enough and is a good area that will make this beneficial. The crappie and bass fishers are chomping at the bit to get these in the water.

Dan Hopkins – The bass and crappie guys are making these structures. There are a couple parts of this conversation. First, can we get this approved to remove these new locations and get the other ones added.

Tony Harris – There is enough structures for these new proposed locations?

Matt Ressler – We will get there. The second part of the conversation is this takes time. Right now, we have sixty structures built. Each one of these locations is getting at least ten to fifteen structures. We are starting at the dam like we had agreed upon. Why not add these other locations in, remove the ones out? These are the only places that are going to hold structure on our lake. We might as well approve this now, that way they can work from the dam and to the north.

John Crotty – Do these additional structures cost the association anything?

Matt Ressler – It costs the association nothing.

Matt Ressler – The Tiki Bar Bass Club is paying for the concrete.

Rob Clarkson – One of the locations on the map that says remove, is in the fishing cove. We just don't want people throwing their anchors out and getting caught in the structure. It made more sense to remove that one.

Matt Ressler – It's only nine feet deep.

Jerry Allen – You said these were approved last year?

Matt Ressler – Yes. The ones that say remove were approved last year.

Jerry Allen – Is there a reason there were only so many approved?

Rob Clarkson – The drops that were approved last year, the approval was to put structure at these spots. There was stuff put in here over ten years ago that was approved then. All that was approved last year was two drops in one year at those locations.

Jerry Allen – When you say drops, I'm assuming you mean structure.

Rob Clarkson – Yes.

Jerry Allen – I'm just trying to understand.

Matt Ressler – We are dropping ten to fifteen structures per location, which is the recommendation from IDNR. What is built right now was only going to cover approximately four locations.

Jerry Allen – I'm just curious as to why these other locations were not approved.

Matt Ressler – We did not know that the water was shallow in these other spots. The other thing is the approved spots is where structures were dropped ten years ago. We are trying to replenish those areas, so when we drop the water this year, the structures won't be a problem. The Fishing Committee is asking to have these other locations approved and remove the other ones.

John Crotty – We are removing two and adding five?

Matt Ressler – Right.

Jerry Allen – Did IDNR decide we put these here?

Matt Ressler – IDNR says if we can add structure anywhere on this lake, then do it. Right now, we have a very low survival rate for the fish that are spawning because we do not have structure in the lake. What was dropped ten years ago is now rotted.

Dan Hopkins – We have no structure in this lake at all and the algae is taking over.

Matt Ressler – We do not. We are dropping these on Saturday at 7AM and hoping to be off the water by 11:30AM before the lake gets too busy. That way we are not in the way hauling these things and putting them in the water. I recommend that if we are in communication with the Association, let's drop these. They are only benefitting the lake.

Tony Harris – Let's do our drop on Saturday and see how it works out and see what we run into. Once we have some experience and or feedback, we can make more drops as needed. That is my recommendation.

Matt Ressler – I'm fine with that.

Dan Hopkins – Motions to modify the structure drop locations as submitted on the drawing.

Matt Ressler – Seconds.

All in Favor.

Motion Carries.

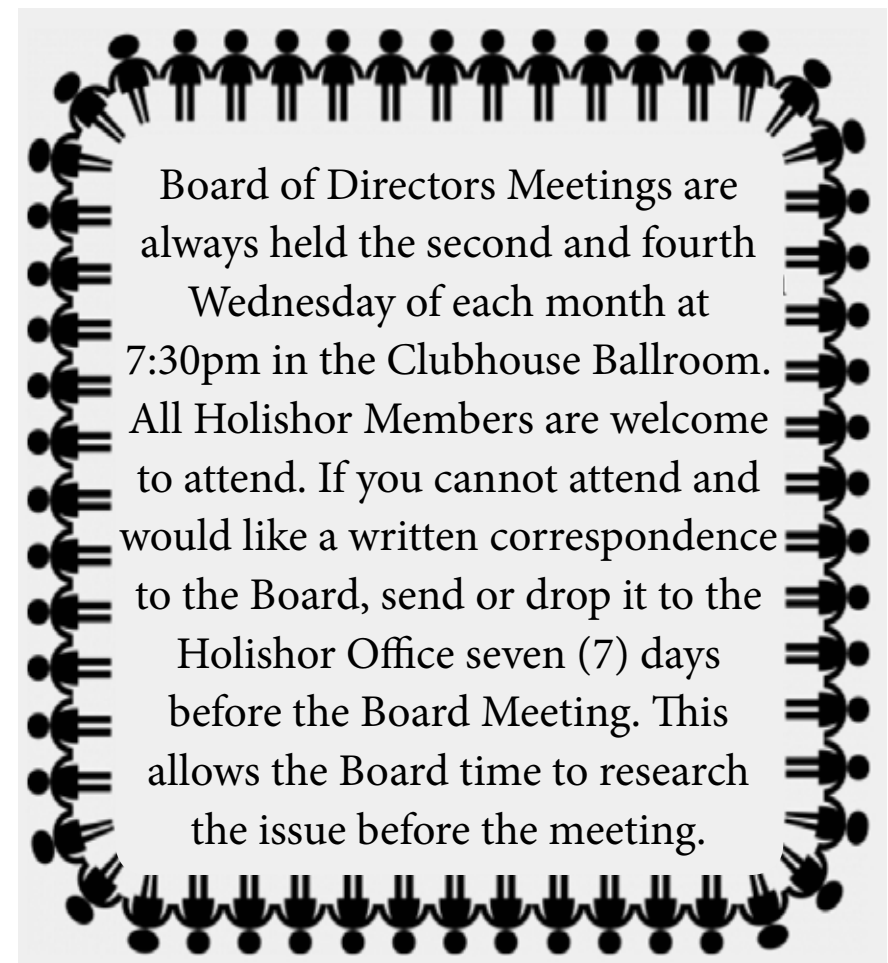

PLEASE READ THE IMPORTANT INFORMATION BELOW REGARDING PERSONAL FLOTATION DEVICES. IT IS IMPARITVE THAT THE APPROPRAITE PFD IS KEPT ON EACH WATERCRAFT WHILE BOATING ON HOLIDAY LAKE AND SU TWAN LAKE. THIS INFORMATION CAN BE FOUND ON PAGES 9 AND 10 IN YOUR HOLIDAY SHORES BOATING RULES.

Personal Flotation Devices from 625 ILCS 45/4 1 No person may operate a watercraft unless at least one U.S. Coast Guard approved PFD of the following types or their equivalent is on board for each person: Type I, Type II or Type III. No person may operate a personal watercraft or specialty prop craft unless each person aboard is wearing a Type I, Type II, Type III or Type V PFD approved by the United States Coast Guard. No person may operate a watercraft 16 feet or more in length, except a canoe or kayak, unless at least one Type IV U.S. Coast Guard approved PFD or its equivalent is on board in addition to the PFD's required in paragraph A of this Section. A U.S. Coast Guard approved Type V personal flotation device may be carried in lieu of the Type I, II, III or IV personal flotation device required in this Section, if the Type V personal flotation device is approved for the activity in which it is being used. When assisting a person on water skis, aquaplane or similar device, there must be one U.S. Coast Guard approved PFD on board the watercraft for each person being assisted or towed or worn by the person being assisted or towed. No person may operate a watercraft unless each device required by this Section is: Readily accessible; in serviceable condition; of the appropriate size for the person for whom it is intended; and legibly marked with the U.S. Coast Guard approval number. Approved personal flotation devices are defined as follows:

- Type I A Type I personal flotation device is an approved device designed to turn an unconscious person in the water from a face downward position to a vertical or slightly backward position and to have more than 20 pounds of buoyancy.
- Type II A Type II personal flotation device is an approved device designed to turn an unconscious person in the water from a face downward position to a vertical or slightly backward position and to have at least 15 1/2 pounds of buoyancy.
- Type III A Type III personal flotation device is an approved device designed to keep a conscious person in a vertical or slightly backward position and to have at least 15 1/2 pounds of buoyancy.
- Type IV A Type IV personal flotation device is an approved device designed to be thrown to a person in the water and not worn. It is designed to have at least 16 1/2 pounds of buoyancy.
- Type V A Type V personal flotation device is an approved device for restricted use and is acceptable only when used in the activity for which it is approved.

No person may operate a watercraft under 26 feet in length unless a Type I, Type II, Type III, or Type V personal flotation device is being properly worn by each person under the age of 13 on board the watercraft at all times in which the watercraft is underway; however, this requirement shall not apply to persons who are below decks or in totally enclosed cabin spaces. The provisions of this subsection I shall not apply to a person operating a watercraft on private property.

Further, no person may operate a watercraft on Holiday or Su Twan lakes unless a Type I, Type II, Type III, or Type V personal flotation device is being properly worn by each person under the age of 13 on board the watercraft at all times in which the watercraft is underway.

BOATING SAFETY

Legal Compliance – “All watercraft operated on Holiday Association Lakes must adhere to and comply with state and federal laws as stated in the Illinois Registration and Safety Act.”

Speed Limit – “The maximum speed of any watercraft operated on Holiday Lake shall be 55mph or as defined in the Reckless or Careless Operation section of the Holiday Shores Boating Rules. Operation of said watercraft shall be in a manner that does not create an exaggerated wake. Intentionally ‘plowing’ or ‘pushing water’ at speeds greater than no-wake, but less than those typically maintained while ‘on plane’ is not permitted.”

Watercraft/Registration – “All watercraft being operated on Holiday and Su Twan Lakes must have a current state registration decal and numbers, **one/current Holiday Shores decal**, and lot numbers affixed.”

Operating Age – The minimum age to operate watercraft on Holiday Lake is 12, providing the individual has passed a state certified boater safety class. Individuals between the ages of 12 and 18 must possess a valid boater safety card to operate watercraft, unless under the direct supervision of a member or a person over the age of 18, who has member consent.

Watercraft Limit – No member shall have more than three motorized watercraft registered to the same membership in operation at one time.

Size Limit – All watercraft being operated on Holiday Lake except pontoon boats with tubular bottoms, are limited to 22 feet in length. Pontoons are restricted to 28 feet.

Traffic Pattern – All watercraft being operated on Holiday Lake must follow a counterclockwise direction of travel, similar to that of operating a motor vehicle on the roadway.

Boating Hours – Boating on Holiday and Su Twan Lakes is permitted 24 hours a day, but watercraft are restricted to No-Wake speeds from sunset to sunrise.

Noise Level Limit – No watercraft may be operated on Holiday or Su Twan Lakes in a manner that exceeds a noise level of 75 decibels. This restriction includes inboard/outboard motors, stereos, etc.

Restricted Areas – No watercraft shall be operated in any manner except prescribed for areas marked No-Wake, Swimming Area, etc. Holiday Lake is considered No-Wake when the lake reaches 9” above full pool and 16” below full pool.

Reckless or Careless Operation – **Careless**: No watercraft shall be operated in a manner that puts any person or property in danger or at a rate of speed that prohibits the driver from stopping the craft within a safe distance. **Reckless**: No watercraft shall be operated in a manner that willfully and wantonly puts life, limb, or property of another person in danger. This restriction applies to actions such as weaving through traffic, jumping wake when visibility is obstructed, following too close to skiers, playing ‘chicken’, or passing another craft in a manner that produces a hazardous wake/wash. This restriction also applies to the misuse of water skis, wake boards, or other devices.

Water Skiing – Water skiers, wake boarders, tubers, etc. may not be towed without at least two competent persons in the tow boat, to observe the individual(s) being towed and provide assistance if distressed/injured.

Distance – Operators must keep a safe and reasonable distance between their craft and other lake users, such as swimmers, downed skiers, fishermen, etc. They must also maintain a distance of 75ft from shore when making a wake. Seventy-five-foot markers have been replaced with new, larger white/blue buoys.

Orange Flag – Operators are required to display a bright orange flag on their vessel **any time they have a skier, tuber, wake boarder, etc. in the water**. The flag must be a 12 inch by 12 inch square and affixed to the highest point of the craft, such as a ski tower or pontoon top.

Racing – Racing of any watercraft on Holiday or Su Twan Lakes is prohibited.

Power Turns – Power Turns (also referred to as 180s or 360s) are permitted as long as the following criteria are met: 1.) Craft is not unreasonably close to another craft, causing it to swerve or take evasive action to avoid a collision. 2.) Not done in a manner that causes the driver and/or passengers to be thrown from the craft. 3.) Not done in a cove or in a manner which causes a nuisance to another member.

Engine Cut-Off – All watercraft (prop-driven and PWC’s) equipped with an engine cut-off device may not be operated unless the device is properly functioning and it’s lanyard is securely attached to the driver.

BEACH AND SWIM SAFETY

Holiday Shores Regulations

1. Beaches located within the Association are restricted to members and guests only.
2. Glass bottles, fires, pets and food are prohibited from the beach area.
3. Persons under the age of 16 are allowed swim: if being escorted by an individual 17 years of age or older or there is a lifeguard on duty.
4. During each shift, a lifeguard is allowed a ten-minute break every hour, during that time, swimmers under 17 years of age must exit the water, if not with an adult.
5. Holishor Association Inc. is not responsible for one's personal items, nor any personal injury sustained while using Association facilities. (water, beach, grounds, etc.)

IL Dept. of Public Health Regulations

1. Beach water is not intended, nor fit, for human consumption. Do not swallow beach water.
2. Beach admittance may be denied to individuals having:
 - Contagious diseases
 - Infections (foot infections, ear infections, vomiting, diarrhea, inflamed eyes, unhealed abrasions or lacerations, skin lesions, or bandages of any kind.
3. Persons under the influence of alcohol or behaving erratically will be denied access/removed from the beach.
4. No food, drink, gum or tobacco products are permitted in the swim area.
5. The use of glass containers is strictly prohibited.
6. Children who are not toilet trained must wear tight fitting plasticized/rubber swim pants.
7. Swimming alone is discouraged.
8. Diving in shallow water is prohibited.
9. Personal conduct that endangers the safety of ones' self, or other beach patrons, is strictly prohibited.
10. Swimming is permitted between sunrise and sunset, except during the times of thunder and/or lightening. Swimmers are required to exit the water during these conditions and remain out for a minimum of 30 minutes following the last detection of thunder or lightning.
11. Pets are prohibited from the beach area.
12. Beach patrons are not permitted to feed local wildlife or entice them to stay in the area. Wildlife harassment is also strictly prohibited.
13. Measures taken to protect ones' self from the sun, such as sunblock, beach umbrellas, etc. are strongly recommended.
