Bids were presented to improve the handicap parking area at the clubhouse. 3 bids were submitted to remove the concrete, prepare and replace the area with of layer of asphalt. Big City Asphalt LLC bid \$18,500 with 3" of asphalt. DeLaurent Construction Co., Inc. bid \$19,492.70 with 4" of asphalt. Keller Paving bid \$15,700 with 2.5" of asphalt. The timeframe for completion on those bids would be 3 weeks. 2 bids were submitted for preparation of area and an overlay of asphalt. Arrow Asphalt Paving bid \$12,300 for a 2" overlay. Keller Paving bid \$12,200 for a 2.5" overlay. The timeframe for completion of the overlay bids would be 2 days.

So I can work with Ben and then get that over to Jerry. John Crotty It is something we want to try to move forward with to pretty quickly also. Dave Decker (1184) Has there been a more discussion about a ramp on Su Twan? Shaun Diltz Just mentioning it, discussion. As far as getting an approval or a date, no. John Crotty It was in the revised budget for 2023. Shaun Diltz So we just need to get bids. Would that be something we get bids on or is that something we can do? Rob Clarkson No. Shaun Diltz Let's work on getting bids on that. Tony Harris One of our requirements as a board is we have to review the financials quarterly. I looked at the ones that are in our packet here, and we're on track for budget. Jennifer Halverson (1829) Just a reminder that the boat safety check event is April 29 from 10:30am to 1:30pm. There will be Coast Guard volunteers at the clubhouse for any boats that are on a trailer, and they'll be at the marina for any boats that are already in the water. They'll have multiple volunteers plus the safety committee will be there to collect data, we're not going to collect anybody's lot. Number one, we just want to know how many boats participated and what typical things failed, so that we can continue to reiterate that with the members.
