We have a correspondence from 1346 regarding the oversized storage sheds that have been allowed to be built in the last couple of years. They feel they are unsightly and not an asset to the community. They are specifically requesting the board and the building committee work together to control this problem by revising the building rules for sheds. They suggest to consider appearance, footage dimensions and/or square footage, in addition to existing building rules. I know this did come up about a year ago, it was proposed to the building committee to look at the building rules around garages and sheds and they didn't have any recommendations for changes at that time, but the board can definitely reach out to them again and take a look at it.

Open Floor

Bob Wheeler (1934) Addressed the board concerning the HSVFD incentive proposal. He presented a list of 44 member's name and lot numbers and what they thought about what the fire department was suggesting. He also stated that not 5% of the people that he asked had anything to do with the website or Facebook and doesn't really think technology has caught up with 50% of our people out here. I mean, as far as your Facebook and your website. I don't think it gives you a true view of what you're looking for. **Kris Williams (750)** representing the pickleball club. The club is asking to be able to reserve the pickleball courts for some organized events coming

Tuesday nights from 6 to 8 pm for beginner lessons through the month of May, and Saturday mornings from 9 to 11am for a ladder league of residents of Holiday Shores beginning April 6 and lasting 10 weeks. We currently have about 25 people that are interested and would like to be included. And we'd like to put it in the Holiday Times and on the website. If we get as many people as we anticipate we would probably like to do another round of that come June, but we'll see how the first one goes. **John Crotty** The last time it was discussed, just like the deck out here or grass area, it's not really something that we've put up for reservations. **Kris** Williams (750) Well, this is something for the community, it'd be kind of like the clubhouse, we do reserve the clubhouse for special events. These are events that are not just for everybody out in the world. This is just for members of Holiday Shores. John Crotty As we are short on board members this evening and we would like to hear the opinions of more members of the board and discuss with the Office on how they would enforce it and things like that, I think we would have to get back to you on the request. Kris Williams (750) One other thing, the courts, they did such a great job on these last year, we are developing cracks, and it would make sense to get some kind of maintenance out there to get these cracks before they get worse. We have one crack that goes the entire length of one half of the tennis court that's probably at its widest 3/8" wide You're going to get a lot of moisture in there, and it is better to do some kind of repair now before it becomes a major issue. And we'd also like to have somebody consider, maybe maintenance, the thought of putting in some more type of a permanent separation between the north and south courts. Right now, we have put a small fence up but we're a little concerned that people are going to trip over that. It just keeps the balls from rolling all over the courts and stuff. John Crotty We can talk to the office. **Angie Webster** Last summer, those cracks came up and I did reach out to the company who actually put that in. And they said the cracks were not significant enough to repair yet, they have to be a certain opening to repair and there's nothing that we can really put in there until they're bigger is what I was told. And there is no warranty on our resurfacing job that we had done. It wasn't purchased at the time that it was done. We will have it reassessed.
