












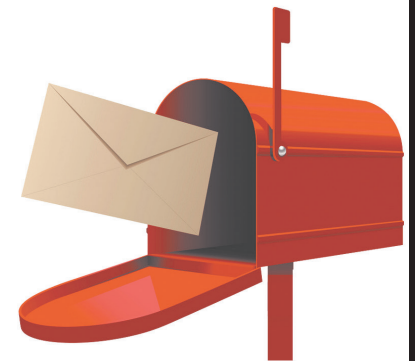

Manager's Report by Angie Webster



2025 draw down has ended and the lake will be filling up naturally. Remember once your building project is complete notify the Office so we can schedule the inspections and close out your permit. Building Committee is only meeting once a month January – March.

In 2026, We have some projects that are still under construction. Joulter's creek and Holiday Point parkway creek dig out. We had some equipment issues and will be getting back to those shortly. We will be adding additional rip rap to several outlots and around larger culverts. I was out doing inspections of some of our outlots recently. We will be taking down dead trees and general brush clean up on multiple lots. Hopefully depending on costs, we will be digging out the middle sediment pond on the north property. This is just to name a few.

I have started the road plan for 2026 which will include 13 to 15 roads, to include extensive repairs on Waikiki Court and Su Twan Drive. Another area that will be addressed is the end of Fountainbleu cul-de-sac, for potential removal of berm and asphalt. These repairs will all depend on cost. We will also be looking at areas that need culvert replacement within the road plan areas.

Something that needs to be addressed again. There is no dumping of any kind, ever on any out-lots. Do not make wood burn piles, do not dump broken up concrete on outlots. If you are dumping broken up concrete that contains rebar, this is an EPA violation, and you can be fined up to \$3000.

There will be 3 seats on the Board of Directors to be voted on at the annual meeting in May. Being on the Board is a good way to serve your community and make it a better place for all. Feel like giving some of your free time to volunteer in another way? Our committees and clubs are always in need of volunteers. We have a list of clubs and committees in the Holiday Times.

Holiday Shores Members,

As we all know, the month of February is on record a cold month and not a lot of people are thinking about fishing. I would encourage you to start preparing for the upcoming fishing season by getting ready! You can start by going through all your tackle and finding out what baits you need to stock up on what baits you currently have so you know your inventory. You can start by checking all your moving baits with treble hooks by replacing the hooks or sharpening the hooks to help prevent you from losing fish. After you have gone through your tackle it's time to go through your fishing rods and reels. It doesn't take long to clean your rods by checking all the guides and eyelets making sure they are in good working order. Next take the time to clean your reels by removing the old line and oiling your reels in the gear area with reel oil and make sure they are in good working order and then make sure you have new line ready to respool with once the season begins. You're going to want to check your boat if you own one to make sure your batteries are in good working order, check tires, check your stickers to make sure you're legal, and clean your boat from all old boat grime and have it ready to hit the water. Also make sure you check your fishing license and make sure to go get a new 2026 license and check all rules and regulations of where you will be fishing to make sure you're legal and ready. Last thing to add, for all Holiday Shores residents your 2025 Holishor decals expire on April 30th and your new decals need to be displayed by May 1st so you don't receive a ticket! Please see the Holishor office if you have any questions about stickers or how to apply them under the rules and regulations of the Holishor Association. Also we are looking for extra funding for fish stocking and if you would like to help fund this program you can look at the bottom of your dues and assessments invoice and send in a separate check or go to the Holishor office and drop off your contribution. Hope this helps and get ready for fishing in 2026!

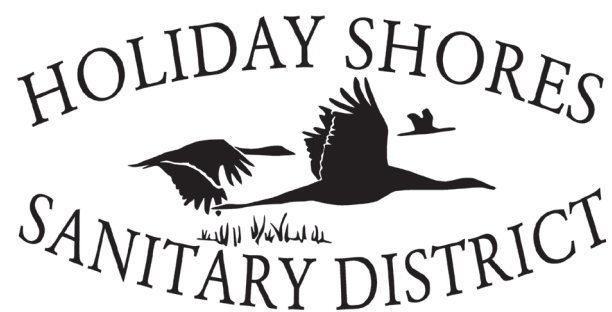

- cheddar cheese, shredded



Burger Sauce:

- 1/3 cup mayonnaise
- 2 tablespoons ketchup
- 1 tablespoon Dijon mustard or yellow mustard
- 1 tablespoon pickle juice
- 1 teaspoon Worcestershire sauce
- 1 teaspoon onion powder
- 1 teaspoon garlic powder
- 1/2 teaspoon smoked paprika

To make burger bowls: Cook French fries according to package directions. In medium skillet over medium-high heat, heat olive oil. Add onion

and saute until translucent, 5-7 minutes. Add ground beef to skillet, breaking up meat with spatula. Add Worcestershire sauce, garlic powder, paprika, salt and pepper; brown until cooked through. Drain and discard excess liquid and grease. HOLIDAY SHORES FIRE DEPARTMENT

Firefighter's Footnote -

The last month and a half of 2025 had cold weather and snow. 2026 has started with unseasonably warm weather, rain, high winds, and possibilities of snow as well. Be prepared for all kinds of weather while traveling during the winter and make sure to have an emergency kit in the car. Keep one handy at home as well. At HSFD, we are keeping prepared too. In January, we had our Ice/Cold Water Rescue & Related Medical Conditions training with other nearby fire departments joining us as well. We also had our community CPR & First Aid class. Thanks to all who attended. Knowing CPR and what to do in emergencies can help save lives. February will be our Driver Safety refresher class and review of Advanced Medical Interventions/Pharmacology/Trauma.

Did anyone guess how many runs we made in 2025? We responded to 238 calls for the year! That is about average for the last several years. There were 225 in 2021, 212 in '22, 243 in '23, and 240 in '24. The highest number of runs we make are medical related with 163 EMS last year; followed by 29 Service Calls; 20 Fires; 10 Good Intent; 8 False Alarms; 6 Hazardous Conditions; and 2 Special Incidents. We received Mutual Aid 9 times last year (6 were automatic); and gave Mutual Aid 15 times (1 was automatic). Last month we had 19 calls: 13 EMS; 3 Assist Invalids; and 1 each for Brush/Grass Fire, MVA with injuries, and Dispatched & Canceled en Route. No Mutual Aid was given or received.

Our fire department is run solely by volunteers. If you would like to be more involved with your community, consider joining Holiday Shores Volunteer Fire Department.

This system is for those who may have a hard time communicating, such as those who have difficulty hearing or speaking, and is to be used only in cases of emergencies. The Edwardsville Intelligencer notes that it may also be used for personal safety during domestic violence altercations, home invasions, human trafficking, strong negative peer pressure, by anyone feeling suicidal or if you are in an area with limited cellular coverage. You need to have an active text or data plan to use, and this system may not be available everywhere outside of Madison County. If you are roaming, it could bounce back to you. ETSB says to simply text 911 in the "to" field, then message your location,



type of emergency (police, fire, EMS), and whether you are safely able to speak. Keep your message brief and specific to your emergency. This service is in English only, no group chats, you must use plain words (no emoji's or slang), and you cannot send pictures or videos as of now. The person who responds will know where you are, but it is not as accurate as speaking to them, so be sure to provide the exact location. If you accidentally send a text to 911, send another to the dispatcher to let them know that there is no emergency. Texting 911 with a false report is a crime! The ETSB and local police departments encourage citizens to "Call if you can, text if you can't." Remember: don't text and drive!

What caution should I be aware of?

Do not park on the road during the snow removal process. Do not push snow on to the roadway, this creates a very hazardous condition.

Clearance of driveway entrances is the responsibility of the resident. Plows may make several passes in order to widen the roads.

What about mailboxes?

The truck will get as close to the mailboxes as possible. It is the homeowner's responsibility to keep the area in front of the mailbox cleared.

Keep mailboxes closed at all times.

What about trashcans on pick up days?

Trashcans & recycle containers must be 4' off the road.

The snowplow drivers will not get out to move your containers and will not be responsible for damage.

USE CAUTION!!

When maintenance is out on the roads, stay a safe distance behind the trucks.

If you cannot see the mirrors on the trucks, they will not be able to see you.

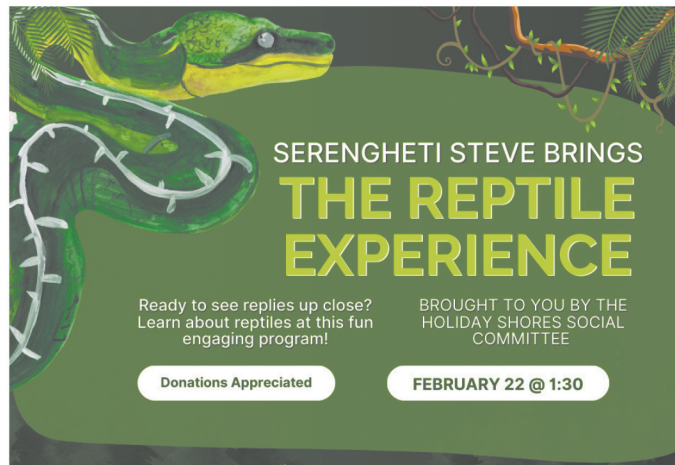
