Manager's Report by Rob Clarkson




It's always nice to see the outdoor activity increase in our community. One of these is walking our dogs. Please remember Madison County does have a leash law. If your pet makes a mess, please be respectful of others property and clean up any waste. After dark poses safety concerns with our communities streetlights. Before all the leaves return take a look and make sure streetlights will not be obstructed on your property. Trim limbs back to and remove anything obstructing the lights. Spring is a great time of year to get out and start cleaning up our property. Overgrown bushes or low hanging trees may also pose a problem for motorist at our street intersections be mindful of this hazard when cleaning up your property this spring. Code Enforcement will be out looking for neglected, unkempt properties and derelict vehicles. Our By-Laws and Rules require residents to keep their property orderly and vehicles licensed or out of the view of the membership. Keeping up with the exterior of our homes not only helps maintain our home values but makes our neighborhood desirable to potential buyers. Yard waste can be burned between sunrise and sunset while attended however NO Construction material is allowed to be burned. Attended Bonfires are allowed.

Dues and Assessments final installment is due May 1st. Members who may have difficulty staying current with this requirement should contact the office and communicate with us any special needs. Dues and Assessments must be paid in full to obtain boat decals and Non-Highway vehicle decals.

ALL watercraft and slow moving vehicles.**

**This includes all non-motorized watercraft
(kayaks, canoes, paddle-boards & paddle-boats).
You must bring your current watercraft registration and
proof of \$300,000 liability insurance on the
watercraft to receive your motorized watercraft decal.**

Slow Moving Vehicle decals are \$15 annually.

**The state requires driver to have a valid driver's
license and proof of minimum liability insurance
coverage be carried within the vehicle.**

1 Corinthians 15:3-8, 12-23

I made a lot of calls to a lot of electrical contractors and found one that actually worked on add a phases. One of their electricians were familiar with it so we wound up fixing it. I think we saved ourselves somewhere in the neighborhood of \$9,000. The elevator is back up and running.

2022 Reserve Schedule Approval for Audit

John Crotty This needs to be reviewed and hopefully approved tonight for the audit that begins next week. They are having some issues with it getting to balance out but we're asking it to be approved as is and then when it gets to the audit they will determine where the issues didn't get balanced. Are there any discussion or questions on the current reserve schedule that needs to be reviewed?

Ski Club Jump

John Crotty The ski club ramp came up at the last meeting and there were some questions on insurance and who covers it. Rob did reach out to our insurance carrier about the ski jump. They notified us at the ski club has their own insurance, liability insurance for the event and for the ski club itself including the ramp. It is not currently covered under Holishor's policy. They do say that we should become an addition to their policy as an additional writer.

Ski Club Requests

Robert Rhea (48) Presented an amended letter from the ski club to the Board detailing asks and asking for Board approval on those asks. The Board requested the letter be updated with the wording for monitoring the lake traffic during the ski show practice and ski show and provide a copy of the Ski Club insurance policy to the office before the agenda deadline for the February 22 board meeting. "The area in front of the clubhouse will be closed with traffic being directed within the 75-foot buoys on the other side allowing people to traverse back and forth on the lake during the 4th of July ski club show practice on July 2 from 8am-11am

and the day of the show on July 4 from noon - 3pm by Holishor personnel". **Rob Clarkson** The fire department also needs to be notified by the ski club to be there with two swimmers on each day. **Robert Rhea (48)** Okay. I don't see a problem, we have insurance through USA Waterski. Everybody on the club is required and we keep track of all the USA Waterski memberships, which provides that insurance, the boats have their own individual policies, which also notes that USA Waterski is on those policies. So we do ensure that if you step on a dock, you step on a boat or you put skis on, or you're in any type of activity in the waterski club that we require that.

Sign Rule

John Crotty A couple of meetings last year some things came up about signs, we noted that our covenants currently say, “no signs of any kind shall be displayed on any lot except those expressly permitted by the bylaws”. Currently, there isn’t anything in the bylaws for signs. There was a proposal put out there that we should start looking at wording to add something into the bylaws. Shawn has made a proposal to add a bylaw that says, “only signs approved by Holiday Shores Board of Directors will be allowed in Holiday Shores.” This proposed bylaw would be voted on at the annual meeting. I would request that the board members review that and at our next meeting talk about any potential changes to it. We will want to get that approved to be brought up to the annual meeting. Same with the membership, if there’s anybody that has anything they’d like to voice into that we’ll be talking about it the next meeting.

New Business

AT&T Fiber

AT&T Fiber representatives presented their plan to install their fiber-optic network in Holiday Shores. 5 levels of service will be offered from 300 MBPS at \$55mo up to 5 GIG at \$180/mo. They are ready to hit the ground running ASAP with construction and can start as soon as next week and should be looking at selling services in October to November. Conversation ensues. **John Crotty** I would actually propose that we post something on our Facebook page and our website about you bringing in the fiber-optic network and ask our members for feedback or any questions with it to come to our next meeting and then at that next meeting we can make our final decision.



HOLIDAY SHORES FIRE DEPARTMENT

Firefighter's Footnote - Last month was the start of Daylight Saving Time where we moved our clocks forward an hour. Make sure you checked or changed the batteries in your smoke and carbon monoxide detectors. In March, we reviewed our CPR/AED training and practiced our SCBA (air tank) Familiarization drills. Next month, we will participate in a hands-on Auto Extrication training. Over the past month, we responded to 19 calls: 8 medical, 3 lift assists and 3 mutual aid including structure fires, 2 brush fires, and 1 each for smell of gas, car accident, and to investigate a potential fire. Anyone interested in seeing how we operate or possibly joining our department can stop by on Monday evenings between 7 and 9pm. You don't need any experience to join our team. Most of our members have learned their firefighting and medical skills while volunteering on our department. There are other ways to help here as well: operating the radio, checking our trucks and equipment, and participating in community outreach programs or fund raisers are other options that are available. You can see what we are all about by looking up our website at www.hsfd.org, or following us on Facebook.

Save The Date: We will host our annual **Fish Fry** dinner again this year on Friday, May 5 from 4-7pm, or until we sell out. We will offer white fish, catfish, hot dogs, pork steaks, bratwurst, potato salad and our famous cole slaw. The Garden Club will be holding its annual Spring Sale here as well. Carry outs and in-house dining are available. Stop by to take home some plants, eat some great food, tour the department, and be a part of our Holiday Shores Fire Department fund raiser.



Medic Minute -It's that time of year for spring cleaning. Be careful painting and using household cleaners – work in well ventilated areas and dispose of hazardous materials safely. You can call local schools, shelters, restoration groups, or nonprofits such as Habitat for Humanity to see if they can use any of your left over paint or supplies. Madison County offers free household hazardous waste drop-offs twice a month on the first Saturday and third Friday of each month at 249 N. Old St. Road in Wood River, IL. Some examples of accepted materials are lead/oil-based paints, cleaners, pesticides, lawn care products, paint thinners, antifreeze, household batteries, fluorescent lights, motor oil, old gasoline, and empty/used propane tanks. This is done by appointment only between 8am and 3pm by calling 618-296-5237 or through a registration page at recycling@co.madison.il.us. If you are throwing away cans with latex paint, make sure any leftover paint in the can is thoroughly dried before disposal - you can add cat litter, sawdust, or newspaper to the can, or leave it open to dry.

Board of Director's meetings are held on the second and fourth Wednesday of each month except for November and December where they only meet the second Wednesday of each month. The BOD meetings average around two hours. Each of these meetings may be followed by an executive session averaging 1-2



hours to discuss personnel, legal or real estate. The Annual Meeting of membership is held the third Saturday in May and averages 3-4 hours. Additionally, based on your expertise or desire, you may want to augment one of our many committees. Terms of Board of Directors are three years. This year, there are openings for 3 three-year terms.

If you never attended a Board meeting, now would be a great time to do so. Have you been a part of any of the many teams of volunteers for activities here at The Shores? If so, you then have some idea of how the community functions.





MAKING SENSE OF INVESTING

BOATING SAFETY

Legal Compliance – “All watercraft operated on Holishor Association Lakes must adhere to and comply with state and federal laws as stated in the Illinois Registration and Safety Act.”

Speed Limit – “The maximum speed of any watercraft operated on Holiday Lake shall be 55mph or as defined in the Reckless or Careless Operation section of the Holiday Shores Boating Rules. Operation of said watercraft shall be in a manner that does not create an exaggerated wake. Intentionally ‘plowing’ or ‘pushing water’ at speeds greater than no-wake, but less than those typically maintained while ‘on plane’ is not permitted.”

Watercraft/Registration – “All watercraft being operated on Holiday and Su Twan Lakes must have a current state registration decal and numbers, **only current Holiday Shores decal**, and lot numbers affixed.”

Operating Age – Anyone born on or after January 1, 1998 who operates a powered watercraft of 10hp or more needs a Boater Safety Certificate. No one under 10 years of age may legally operate any type of motorboat. Persons aged 10 or 11 years may not operate any type of motorboat unless they are supervised by a parent or a guardian, or a competent adult who is at least 18 years old, designated by a parent or a guardian. No one who is at least 12 and less than 18 years of age may operate a motorboat unless: They have in possession a valid Boating Education Certificate of Competency issued by the Illinois Department of Natural Resources, or they are under the direct supervision of a parent or guardian, or a competent adult who is at least 18 years old, designated by a parent or guardian. No one may operate a watercraft unless a member, associate member or accompanied by a member.

Watercraft Limit – No member shall have more than three motorized watercraft registered to the same membership in operation at one time.

Size Limit – All watercraft being operated on Holiday Lake except pontoon boats with tubular bottoms, are limited to 22 feet in length. Pontoons are restricted to 28 feet.

Traffic Pattern – All watercraft being operated on Holiday Lake must follow a counterclockwise direction of travel, similar to that of operating a motor vehicle on the roadway.

Boating Hours – Boating on Holiday and Su Twan Lakes is permitted 24 hours a day, but watercraft are restricted to No-Wake speeds from sunset to sunrise. Su Twan only electric or muscular powered watercraft...NO ENGINES

Noise Level Limit – No watercraft may be operated on Holiday or Su Twan Lakes in a manner that exceeds a noise level of 75 decibels. This restriction includes inboard/outboard motors, stereos, etc.

Restricted Areas – No watercraft shall be operated in any manner except prescribed for areas marked No-Wake, Swimming Area, etc. Holiday Lake is considered No-Wake when the lake reaches 9” above full pool and 16” below full pool.

Reckless or Careless Operation – **Careless**: No watercraft shall be operated in a manner that puts any person or property in danger or at a rate of speed that prohibits the driver from stopping the craft within a safe distance. **Reckless**: No watercraft shall be operated in a manner that willfully and wantonly puts life, limb, or property of another person in danger. This restriction applies to actions such as weaving through traffic, jumping wake when visibility is obstructed, following too close to skiers, playing ‘chicken’, or passing another craft in a manner that produces a hazardous wake/wash. This restriction also applies to the misuse of water skis, wake boards, or other devices.

Water Skiing – Water skiers, wake boarders, tubers, etc. may not be towed without at least two competent persons in the tow boat, to observe the individual(s) being towed and provide assistance if distressed/injured.

Distance – Operators must keep a safe and reasonable distance between their craft and other lake users, such as swimmers, downed skiers, fishermen, etc. They must also maintain a distance of 75ft from shore when making a wake. Seventy-five-foot markers have been replaced with new, larger white/blue buoys.

Orange Flag – Operators are required to display a bright orange flag on their vessel **any time they have a skier, tuber, wake boarder, etc. in the water**. The flag must be a 12 inch by 12 inch square and affixed to the highest point of the craft, such as a ski tower or pontoon top.

Racing – Racing of any watercraft on Holiday or Su Twan Lakes is prohibited.

Power Turns – Power Turns (also referred to as 180s or 360s) are permitted as long as the following criteria are met: 1.) Craft is not unreasonably close to another craft, causing it to swerve or take evasive action to avoid a collision. 2.) Not done in a manner that causes the driver and/or passengers to be thrown from the craft. 3.) Not done in a cove or in a manner which causes a nuisance to another member.

Engine Cut-Off – All watercraft (prop-driven and PWC’s) equipped with an engine cut-off device may not be operated unless the device is properly functioning and it’s lanyard is securely attached to the driver.
