The Marina Ramp Cable lock has been changed and utilizes a key that cannot be removed until the lock has been secured. Lets all do our part to secure the lake from non-members.

Spring clean-up is being conducted thru out the Community and we want to thank you for the great effort. Overall grass is being mowed, repairs to homes, decks, sheds and docks is being conducted and our Community is well kept. There are a few exceptions and we will bring this to the attention of the offenders. We all want a common sense approach to maintenance of property which is; mow the grass and keep all structures in an as built status.



Roadway Improvement Proposal

Jerry Allen At the Board's executive session on March 24, 2021, the Association attorney stated that per the current bylaws, multiple lot owners could not be assessed fees based on each property they own. After the Roadway Improvement Committee (RIC) was notified of the Association attorney's opinion, Jane Unsell, who is a member of the RIC and an attorney, reached out for clarification.

Per the two attorneys' conversation, the following was revealed:

- 1. The Association attorney had not been asked to review the RIC proposal.
- The Association attorney was asked only to review the current bylaws to confirm whether a multiple lot owner could be assessed fees based on each property owned. The Association attorney's opinion shared to the Board was that a multiple lot owner could contest said fees and if contested, the Board would not be able to collect per the current bylaws.

It is the committee's opinion that since the RIC proposal is an amendment to the current bylaws, a vote by the membership would be required to approve the amendment. Once the Amendment is approved by the association, the committee believes that a multiple lot owner could not contest a separate assessment based on road frontage ownership.

Based on the current state of the proposal, membership communication and education necessary for this amendment to pass, the RIC has decided to retract its proposal for consideration at the 2021 Annual Meeting.

If there are any members who would like to participate on this committee or have ideas for increasing revenue for our roadways, please feel free to reach out to me. We appreciate your comments and suggestions.

I want to personally thank the committee members for their countless hours of work and dedication to this effort. The committee members beside myself are: Kay Slayden, Jane Unsell, Cindy Rives and Patti Brown. It should be noted that two of the RIC members are multiple lot owners. John Crotty Any questions or comments for Jerry?

Tony Harris Are they looking to make another proposal you think. Jerry Allen

Yes, I think what we're going to do is reconvene and see what we need to do. Again, looking at the communications and I think one of the things that we were having issues with was education of our membership on the benefits of the actual proposal is. So we're going to work on that, and how we can get the communication out in a better manner. But we also want to see if there's people in the membership who'd be like to be part of the committee so that we could perhaps get some different ideas or just have some different input to the to the overall proposal. **Tony Harris** The covenants and the bylaws are obviously changeable, but you would have to change a significant portion of the bylaws. Pretty much the whole concept, understanding that it's a membership-based community to go forward with the current proposal. So you'd be changing a large portion of those to do that. **Jerry Allen** Well, the attorney that we had on the committee reviewed the bylaws and thought that the proposal we put forth would fall within the bylaws even though it's an amendment to those. Again, our association attorney reviewed what he was asked to review which was the current bylaws versus the amendment that the proposal is based on. So anyway, we're going to retract it for 2021 and hope to have something coming up for the for the upcoming Annual Meeting in 2022.



Source of Drinking Water

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the Bround, it dissolves naturally-occurring minerals and, in some cases, redicactive material, and can click up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, brban storm water runoff, and septic systems.
- Radioactive conteminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

prinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by wublic water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Some people may be more vulnerable to contaminants in drinking water than the general population.

Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HTV/AIDS or other immune system disorders, some elderly and infants can be particularly at risk from infections. If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. We cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking er cooking. If you are concerned about lead in your water, you may wish to have your water tested. 3 cups Honeycrisp apples, peeled, cored and diced

3 teaspoons cinnamon

6 tablespoons, plus 2 cups, sugar, divided

3 cups flour

3 teaspoons baking powder

1 teaspoon salt

1 cup oil

4 eggs, beaten

1/4 cup orange juice 1 teaspoon vanilla

icing (optional)

Heat oven to 350 F. In medium bowl, mix apples, cinnamon and 5 tablespoons



sugar until combined. Set aside. In large bowl, mix flour, 2 cups sugar, baking powder and salt until combined. Form well in middle of mixture. Add oil, eggs, orange juice and vanilla; mix until blended.

PERSONAL FLOTATION DEVICES

PLEASE READ THE IMPORTANT INFORMATION BELOW REGARDING PERSONAL FLOTATION DEVICES. IT IS IMPERATIVE THAT THE APPROPRIATE PFD IS KEPT ON EACH WATER-CRAFT WHILE BOATING ON HOLIDAY LAKE AND SU TWAN LAKE. THIS INFORMATION CAN BE FOUND ON PAGES 9 AND 10 IN YOUR HOLIDAY SHORES BOATING RULES.

Personal Flotation Devices from 625 ILCS 45/4 1 No person may operate a watercraft unless at least one U.S. Coast Guard approved PFD of the following types or their equivalent is on board for each person: Type I, Type II or Type III. No person may operate a personal watercraft or specialty prop craft unless each person aboard is wearing a Type I, Type III or Type V PFD approved by the United States Coast Guard. No person may operate a watercraft 16 feet or more in length, except a canoe or kayak, unless at least one Type IV U.S. Coast Guard approved PFD or its equivalent is on board in addition to the PFD's required in paragraph A of this Section. A U.S. Coast Guard approved Type V personal flotation device may be carried in lieu of the Type I, II, III or IV personal flotation device required in this Section, if the Type V personal flotation device is approved for the activity in which it is being used. When assisting a person on water skis, aquaplane or similar device, there must be one U.S. Coast Guard approved PFD on board the watercraft for each person being assisted or towed. No person may operate a watercraft unless each device required by this Section is: Readily accessible; in serviceable condition; of the appropriate size for the person for whom it is intended; and legibly marked with the U.S. Coast Guard approval number. Approved personal flotation devices are defined as follows:

- Type I A Type I personal flotation device is an approved device designed to turn an unconscious person in the water from a face downward position to a vertical or slightly backward position and to have more than 20 pounds of buoyancy.
- Type II A Type II personal flotation device is an approved device designed to turn an unconscious person in the water from a face downward position to a vertical or slightly backward position and to have at least 15 1/2 pounds of buoyancy.
- Type III A Type III personal flotation device is an approved device designed to keep a conscious person in a vertical or slightly backward position and to have at least 15 1/2 pounds of buoyancy.
- Type IV A Type IV personal flotation device is an approved device designed to be thrown to a person in the water and not worn. It is designed to have at least 16 1/2 pounds of buoyancy.
- Type V A Type V personal flotation device is an approved device for restricted use and is acceptable only when used in the activity for which it is approved.

No person may operate a watercraft under 26 feet in length unless a Type I, Type II, or Type V personal flotation device is being properly worn by each person under the age of 13 on board the watercraft at all times in which the watercraft is underway; however, this requirement shall not apply to persons who are below decks or in totally enclosed cabin spaces. The provisions of this subsection I shall not apply to a person operating a watercraft on private property.

Further, no person may operate a watercraft on Holiday or Su Twan lakes unless a Type II, Type III, or Type V personal flotation device is being properly worn by each person under the age of 13 on board the watercraft at all times in which the watercraft is underway.

BEACH AND SWIM SAFETY

Holiday Shores Regulations

- 1. Beaches located within the Association are restricted to members and guests only.
- 2. Glass bottles, fires, pets and food are prohibited from the beach area.
- 3. Persons under the age of 16 are allowed to swim: if being escorted by an individual 17 years of age or older or there is a lifeguard on duty.
- 4. During each shift, a lifeguard is allowed a ten-minute break every hour, during that time, swimmers under 17 years of age must exit the water, if not with an adult.
- 5. Holishor Association Inc. is not responsible for one's personal items, nor any personal injury sustained while using Association facilities. (water, beach, grounds, etc.)

IL Dept. of Public Health Regulations

- 1. Beach water is not intended, nor fit, for human consumption. Do not swallow beach water.
- 2. Beach admittance may be denied to individuals having:
 - · Contagious diseases
 - · Infections (foot infections, ear infections, vomiting, diarrhea, inflamed eyes, unhealed abrasions or lacerations, skin lesions, or bandages of any kind.
- 3. Persons under the influence of alcohol or behaving erratically will be denied access/removed from the beach.
- 4. No food, drink, gum or tobacco products are permitted in the swim area.
- 5. The use of glass containers is strictly prohibited.
- 6. Children who are not toilet trained must wear tight fitting plasticized/rubber swim pants.
- 7. Swimming alone is discouraged.
- 8. Diving in shallow water is prohibited.
- 9. Personal conduct that endangers the safety of ones' self, or other beach patrons, is strictly prohibited.
- 10. Swimming is permitted between sunrise and sunset, except during the times of thunder and/or lightening. Swimmers are required to exit the water during these conditions and remain out for a minimum of 30 minutes following the last detection of thunder or lightning.
- 11. Pets are prohibited from the beach area.
- 12. Beach patrons are not permitted to feed local wildlife or entice them to stay in the area. Wildlife harassment is also strictly prohibited.
- 13. Measures taken to protect ones' self from the sun, such as sunblock, beach umbrellas, etc. are strongly recommended.

feet up, running to a neighbor's culvert, and it doesn't function very well. And it was eroding, you guys came out and added some rocks. It kind of slowed it down but now the erosion is coming back. And I was told that it was on be put on the agenda for 2020 but covid started so I didn't come back to follow up and I was just curious where that was as it's coming back to be a problem. Tony Harris Rob do you know where that one is. **Rob Clarkson** Yes, I know exactly where it is. It was looked at when we did the entire ditching going forward. And it wasn't as much of as priority as some of the areas that are flooding. So it basically got priority 2 instead of priority 1. And if it is eroding again then we can put some more riprap around and solve that problem for a little longer, put a bandaid on it basically until we have the money to actually get to that area. **Jeremy Jasudowicz** (1041) So we talked about, you know, like I said, it's going back from 2019. I don't know if there's a way to get that bumped up a little bit, because it is eroding and then it came back. We did try a repair job but I'm sure you know, we had to pull it back because it started flooding that corner pretty bad. So we pulled out where that black sheeting was, we pulled that back because it was flooding, but kept the riprap but it's just starting to erode again. Rob Clarkson Black sheeting is soil cloth. Jeremy Jasudowicz (1041) It was backing up way too much, so we pulled that back. **Tony Harris** We can have Rob look at and see if there's something they could do with that or see if they can address it with some more rock, Generally what we try do on the ditching and on the roads is prioritize things in worst to best and start with the worst and keep working our way forward. I'm not actually familiar with that area so I can't say how it compares to the others. These guys have been out and looked at it so we'll see what we can do, maybe do little improvements to keep it going, see if it needs some more riprap or something. Jeremy Jasudowicz (1041) Do you have a guesstimate idea of when you might be able to put that culvert in? **Tony Harris** I have to have the plan to see where it was ranked. I don't have that with me tonight, we can certainly look into it and let you know. I don't have that information with me. Donna Kinder (341) I have three questions. I received my packet this week. There was no agenda. Also, I'm concerned about just having 75 limit, wondering if it could be out in the parking lot. You know, sometimes we have pretty good weather at that time. And also, another question is, there was no envelope in the package to return the ballots. And I noticed then that we have to come up here and turn them in. So will you be receiving as many ballots that way? Or why was there a change? **Tony Harris** So the agenda, I can't really answer that one. There should have been one in there. **Donna Kinder (341)** There wasn't. **Tony Harris** We can definitely get one posted on the website. As far as the parking lot, we could consider that.

Generally, what we found is, if we're not voting on something that affects the dues, we generally do good to get 40 or 50 people here. So I'm not sure that 75 will be an issue. Generally, the times we've had packed houses was when there was some proposal that was going to change the dues being paid. And then obviously its standing room only. But on the other years, when there hasn't been something that really affects a person's pocketbook or the dues it's slim. So I don't know if the 75 will really be an issue or not. The reason there was no envelope was, let's see, this is 21. Rob Clarkson Because you can't mail it back. Tony Harris Yes, you can't mail it back. In 19' we changed to add the absentee ballot, we inadvertently changed some of the language in the rule. And so now everything is covered in the same absentee ballot language. And so to do that, you have to bring a valid ID and get it verified that you're a member in good standing when you cast your ballot. And so you have to come up to the clubhouse. So we're going to have to propose some language changes that will go to the membership for the 2022 meeting, to change that back so they'll be able to mail in their ballot for Board of Directors only. Donna Kinder (341) It had our names on it you know, whenever you returned it, so you knew, **Tony Harris** Previously to the change, you could mail in your board of director's ballot, that was the only thing you could vote absentee, everything else you had to come to the meeting and vote. And we were trying to change it so that people could vote absentee if they were going to be out of town that weekend or busy or people that live out of town would be able to vote and send their ballots in. Well, when we did it, trying to make sure that we had only members in good standing voting, we had it so you had to present a valid ID at the office at the time you cast your ballots, so they could see it, check it and then put it in the ballot box. And so we need to really change that language. Donna Kinder (341) Okay, so what's going to be on the agenda? Tony Harris It's really just the board of director's vote and the budget? **Donna Kinder (341)** Okay. Thank vou. Rob Clarkson I'm pretty sure that it was in the cover letter that stated that it was just those two. There was two positions being voted on for the board of directors and the budget for the year. **Tony Harris** And I should say that's the only items that'll be voted on. We'll have the other items that are on the agenda, which is, you know, thanking previous board members that are rolling off, invocation, those types of things. But the only items to be voted on are the board of directors and the budget. Kenneathia Hagen (1991) Back in October, I actually asked the question, what was the security plan for 2021? Because last vear, it just wasn't a good plan, whatever that may have been because of the lack of security presence on the lake. I asked the same question in January and I received we're working on it. And now we're in boating season, I witnessed something over

Culvert-Ensign Circle

Anthony Harrell Rob met with Stutz and ordered the locates for the utilities. A 12-inch culvert was delivered to the job site. As soon as the locates are done for the utilities and completed, Madison Telco will be notified to have an observer present during excavation and work will proceed. Rob Clarkson I do have an update on that. The culvert was put in, the cleanup of the site has to be done with the asphalt patch. That's all that's left. Anthony Harrell Thank you Rob. I should state Dan Hopkins is not here tonight. As of tonight, he's officially resigned from the board of directors. So we will see what happens with the votes for the new board members and then after the election, we will appoint someone to replace Dan.

Anthony Harrell There are no updates yet, from as far as estimates and everything for that, we are going to get some more estimates on future repairs for the elevator.

Fish Stocking

Anthony Harrell The supplier that we went through, they still have the pure stripers that they owe us. Evidently, they're having a hard time getting those. Rob is going to look into a different supplier for getting us the stripers. Anything to add to that, Rob. Rob Clarkson I don't have a very good feeling that is going to happen this year. Matt Ressler Can we take that money that's allocated for the stripers and put it in the flatheads and just get those in the lake and start curing the problem? Anthony Harrell Something we can discuss if it doesn't look like we're going to be able to get the pure stripers then we can either get more hy-

brids, or we can get more flatheads. Matt Ressler How much money do we have left in that budget? Rob Clarkson I'd have to look, it was somewhere around \$4,500 to \$5,000. **Matt Ressler** I would say my recommendation would be split it between hybrid stripers and flathead catfish. The hybrids will control the shad population and flatheads will help control the crappie population. So my recommendation would be to take the remaining money and split it between the two and continue looking for stripers for stocking of next year. **Brian Wood** Is the supply on the flatheads and the hybrids there? **Rob Clarkson** Flatheads are caught and brought here. I looked into trying to obtain fingerlings on them and three places that I called didn't have a successful year. So it was a bad year for flathead breeding. Matt Ressler The thing with the flatheads the reason we put them in here at that size, five to seven pounds is to start eating these crappie in the lake instead of putting the fingerlings in because it is going to take longer to balance it out. **Anthony Harrell** So I'll take a motion if that's what we want to do. **Tony Harris** So is the availability of the hybrids and the flatheads there to get the additional fish? Rob Clarkson I'm sure we can get the flatheads, I'll have to check on the hybrids. **John Crotty** We can word it so that money can go towards either one of those, whatever we get the most of or whatever is available. **Matt Ressler** So I would do our best of ability the money leftover allocated for the hybrid stripers and flathead catfish between the two, and if the hybrids aren't available.... then if the hybrids aren't available, because you know you're running into a problem you don't want to overstock this like with flatheads because then you're going to have another problem on your hands. **Tony Harris** After we got regular stripers, we were going to see how much money was left to see how many of the flatheads we could buy, if I remember the conversation. So I'm not sure how much money we have, I'm just curious how much money we have left. **Rob Clarkson** I'll get a line item on it tomorrow. **Matt Ressler** I say we just split it between the two. If we're not able to get the hybrid stripers, order largemouth bass. That's another option from the hatchery. **John Crotty** Sounds like to me we need to wait to the next meeting to get some more information to know what's actually available. Tony Harris I would like to because if there's an issue, we could get the flatheads, but we're saying we could have too many, we need to know how much money we have to see how many we can get of these things to know what right mix is. Rob Clarkson You can also carry that money over too. Brian **Wood** Or we could make a motion now and agree upon splitting it in half and if we can't get the hybrids, then we table it till the next week. **John Crotty** At least spend half of it on flatheads now, get that going. If we can get hybrids get them, if we can't whatever money is left we'll figure out what to do with it.

Brian Wood Makes a motion to take the remaining money that's left over from the fish stocking and split it between hybrid stripers and flathead catfish, regardless of the availability of the hybrid stripers we'll do half of that allocation towards flathead catfish. If the hybrids are available, we'll buy the hybrids, if they're not available we will save that money and discuss it at the next meeting.



AMERICAN FLAG CAKE

For the flag cake:

1/2 cup unsalted butter softened to room temperature (1 stick)

1 cup granulated sugar

1/2 cup honey

2 large eggs at room temperature

2 teaspoons vanilla extract

3/4 cup nonfat plain Greek yogurt at room temperature

1 1/4 cups white whole wheat flour*

1 cup all-purpose flour

1 teaspoon baking soda

1/2 teaspoon kosher salt

3/4 cup milk plus 2 tablespoons

For the frosting and decoration:

12 ounces reduced-fat cream cheese Neufchatel, at room temperature

6 tablespoons unsalted butter at room temperature

1 1/3 cups powdered sugar

1/4 cup nonfat plain Greek yogurt at room temperature

1 teaspoon pure vanilla extract

1 cup fresh blueberries


2-3 cups sliced fresh strawberries

Preheat the oven to 325 degrees F. Generously grease and lightly flour an 11x17-inch half-sheet pan or coat with baking spray (the floured kind, like this). Set aside. In the bowl of a stand mixer fitted with the paddle attachment or a large bowl with a hand mixer or spoon, cream the butter for 1 minute on medium speed, until it is smooth and creamy. Add the sugar on medium speed and beat until fluffy and light in color. Beat in the honey, then the eggs and vanilla until smooth and nicely combined, stopping to scrape down the sides and bottom of the bowl a few times. The mixture may look curdled. Beat in the yogurt on medium-high speed until blended. In a large bowl, whisk together the whole wheat flour, all-purpose flour, baking soda, and salt. Pour one-third of the flour mixture into the butter mixture. Beat on low speed for 5 seconds, then pour in half of the milk. Beat on low speed for 5 seconds. Repeat with the next third of the flour, then the remaining half of the milk. Add the last third of the flour and beat just until combined and the batter is smooth. Do not overmix. Spread the cake batter into the prepared pan, smoothing it into a thin, even layer with a rubber spatula or offset spatula. Bake for 18 to 22 minutes or until the top is lightly browned and a toothpick inserted in the center comes out clean, rotating the pan 180 degrees

once halfway through. Place the baked cake on a wire rack and let cool in the pan completely. Meanwhile, make the frosting.

For the frosting: In the bowl of a stand mixer fitted with the paddle attachment or a large bowl with a hand mixer or spoon, beat the cream cheese, butter, powdered sugar, yogurt, and vanilla on medium speed until smooth and combined. Spread the frosting over the cooled cake. Arrange blueberries in rows in top left corner to form the "star" portion of the flag. Line the strawberry slices in 5 rows to form the "stripes." Refrigerate until ready to serve

Notes *You can substitute the same amount of all-purpose flour for the 1 1/4 cups white whole wheat flour. If you make this swap, reduce the amount of milk in the recipe to 3/4 cup plus 1 tablespoon. Cake can be made 1 day in advance, covered tightly at room temperature, and then frosted before serving. Frosting can also be made 1 day ahead of time and stored in an airtight container in the refrigerator. Let come to room temperature for easier frosting of the cake. Store leftovers in the refrigerator, tightly covered, for up to 3 days. You can also remove the fruit and store for up to 5 days in the refrigerator or freeze for up to 3 months. BOATING SAFETY

<u>Legal Compliance</u> – "All watercraft operated on Holishor Association Lakes must adhere to and comply with state and federal laws as stated in the Illinois Registration and Safety Act."

Speed Limit – "The maximum speed of any watercraft operated on Holiday Lake shall be 55mph or as defined in the Reckless or Careless Operation section of the Holiday Shores Boating Rules. Operation of said watercraft shall be in a manner that does not create an exaggerated wake. Intentionally 'plowing' or 'pushing water' at speeds greater than no-wake, but less than those typically maintained while 'on plane' is not permitted."

<u>Watercraft/Registration</u> – "All watercraft being operated on Holiday and Su Twan Lakes must have a current state registration decal and numbers, **one/current Holiday Shores decal**, and lot numbers affixed."

<u>Operating Age</u> – The minimum age to operate watercraft on Holiday Lake is 12, providing the individual has passed a state certified boater safety class. Individuals between the ages of 12 and 18 must possess a valid boater safety card to operate watercraft, unless under the direct supervision of a member or a person over the age of 18, who has member consent.

<u>Watercraft Limit</u> – No member shall have more than three motorized watercraft registered to the same membership in operation at one time. <u>Size Limit</u> – All watercraft being operated on Holiday Lake except pontoon boats with tubular bottoms, are limited to 22 feet in length. Pontoons are restricted to 28 feet.

<u>Traffic Pattern</u> – All watercraft being operated on Holiday Lake must follow a counterclockwise direction of travel, similar to that of operating a motor vehicle on the roadway.

<u>Boating Hours</u> – Boating on Holiday and Su Twan Lakes is permitted 24 hours a day, but watercraft are restricted to No-Wake speeds from sunset to sunrise.

Noise Level Limit – No watercraft may be operated on Holiday or Su Twan Lakes in a manner that exceeds a noise level of 75 decibels. This restriction includes inboard/outboard motors, stereos, etc.

<u>Restricted Areas</u> – No watercraft shall be operated in any manner except prescribed for areas marked No-Wake, Swimming Area, etc. Holiday Lake is considered No-Wake when the lake reaches 9" above full pool and 16" below full pool.

Reckless or Careless Operation – Careless: No watercraft shall be operated in a manner that puts any person or property in danger or at a rate of speed that prohibits the driver from stopping the craft within a safe distance. Reckless: No watercraft shall be operated in a manner that willfully and wantonly puts life, limb, or property of another person in danger. This restriction applies to actions such as weaving through traffic, jumping wake when visibility is obstructed, following too close to skiers, playing 'chicken', or passing another craft in a manner that produces a hazardous wake/ wash. This restriction also applies to the misuse of water skis, wake boards, or other devices.

<u>Water Skiing</u> – Water skiers, wake boarders, tubers, etc. may not be towed without at least two competent persons in the tow boat, to observe the individual(s) being towed and provide assistance if distressed/injured.

<u>Distance</u> – Operators must keep a safe and reasonable distance between their craft and other lake users, such as swimmers, downed skiers, fishermen, etc. They must also maintain a distance of 75ft from shore when making a wake. Seventy-five-foot markers have been replaced with new, larger white/blue buoys.

<u>Orange Flag</u> – Operators are required to display a bright orange flag on their vessel **any time they have a skier, tuber, wake boarder, etc. in the water**. The flag must be a 12 inch by 12 inch square and affixed to the highest point of the craft, such as a ski tower or pontoon top.

Racing – Racing of any watercraft on Holiday or Su Twan Lakes is prohibited.

<u>Power Turns</u> – Power Turns (also referred to as 180s or 360s) are permitted as long as the following criteria are met: 1.) Craft is not unreasonably close to another craft, causing it to swerve or take evasive action to avoid a collision. 2.) Not done in a matter that causes the driver and/or passengers to be thrown from the craft. 3.) Not done in a cove or in a manner which causes a nuisance to another member.

Engine Cut-Off – All watercraft (prop-driven and PWC's) equipped with an engine cut-off device may not be operated unless the device is properly functioning and it's lanyard is securely attached to the driver.


