

Herbicides can have a negative effect on our water supply and effect the eco system of our aquatic asset.

Keeping up with the exterior of our homes not only helps maintain our home values but makes our neighborhood desirable to potential buyers. Yard waste can be burned between sunrise and sunset while attended however NO Construction material can be burned.

Dues and Assessments final installment are due May 1st. Members who may have difficulty staying current with this requirement should contact the office and communicate with us any special needs.







Fireworks

John Crotty We have received the contract for this year's fireworks, and it does include the additional \$6,000 that we got back from last year's fireworks not being as good as we hoped. There were significant increases in shipping cost and delays in shipping so they're looking to get this signed to get moving forward as soon as possible. Tony Harris That shipping seems really bad, much higher. Shaun Diltz We're being gifted essentially \$6,000 and we are getting the same amount. John Crotty Shipping has increased so it would have been really low if it hadn't been for the credit. Robert Wittkamp So basically, we shouldn't expect to see anything grander. Hopefully more efficient and better planned out than last year. Shaun Diltz I would say nothing grander. But if these are the norm we can get some bids

for 2023, see what the options are out there. Jerry Allen So basically, if we didn't get the extra \$6,000, this year, our show would be two thirds of what a normal show would be because of the cost of shipping to get over here. So the question comes, do we then have to proceed to budget more in our budget to allow for higher expenses for the fireworks? Otherwise, we're going to have a show that nobody wants to come to because it's not very long. Tony Harris Right, we are going to have to do something different. Robert Wittkamp It's a big deal. People want a show. Anthony Harrell Did they give us the option to do a one-time payment in advance and get 8% more fireworks this year? **John Crotty** 8% free for early payment. **Shaun Diltz** Which we've never done. I'm for paying early, see if we can get a little bit more out of it. And that's a good point, Jerry, I think we should probably as a board get some kind of shell count to what we would think be acceptable for other companies to bid on. **Jerry Allen** At least the timeframe, maybe 30 minutes of the show or 25 minutes of a show. But we'll have to have more cash to have a better show in 2023. Robert Wittkamp I would say pay up front, get as much as we can out of them. **John Crotty** We had 678 last year. So we're getting an extra 94 extra shells. It has gone from 678 to 772 shot counts for the \$6000. We would have been at 504 shots with the shipping cost increase without the \$6000. So it's making up some of it and getting us an additional 94.

Road Plan Options

John Crotty There are 2 plan options. Option 1 Includes a number of roads that were in line based on the five-year road plan which is estimated to be 25,247' with intersections. On option 2, Rob and the maintenance group has looked at the increased road traffic on Holiday Point Parkway and has made a proposal to potentially change the roads that we're doing this year and include Holiday Point Parkway on that as it is a lot wider road. The total footage would be less, but we'd still include some of the roads that were part of that package originally for option 1. So option 1 would be to do all the roads we'd planned, more residential side smaller roads. Option 2 would be taking only some of those roads and do all of Holiday Point Parkway. **Tony Harris** Why if Holiday Point Parkway is a priority 1, why was it not included in option 1 to begin with. **Rob Clarkson** Your priorities are based on use of the road, condition of the road currently and our opinion of what that road is going to be like a year down the road. That's where we based where I thought maybe we want to look at Holiday Point Parkway, because there's going to be a lot more traffic on that road this year. It's already showing signs of cracking and whatnot, fix it now before it's really bad or cross your fingers and go for another year. That is what made it a priority 1 in my mind? **Anthony Harrell** My thought is these residential roads, everybody's kind of concerned about why my road never gets fixed. My thought would be select option 1 and then if there's bad areas on Holiday Point Parkway, we handle that internally with our guys and handle those bad areas and get it by until next year, and we stick with that five-year plan that we developed and we're not messing with the five-year plan that way. Jerry Allen I guess it really comes down to what monies we have available in addition to what we've already budgeted for this. And if we had some money available after we get



Firefighter's Footnote - Spring is here and we hope you have been able to enjoy the outdoors a little more. It's also a time for spring cleaning, and we have been doing the same at HSFD, where we've been busy cleaning and straightening up the firehouse. We have also continued with our training. In March, we went over our SCBA (air tanks) Familiarization and Drills, followed by a Consumption test. We attended a CPR/AED class with hands-on training. Coming up in April, we will review Building Construction and Fire Flows along with attending a class about Auto Extrication taught by IFSI (Illinois Fire Safety Institute). Don't forget to save the date for our annual Fish Fry which will be held on Friday, May 6. As usual, drop by any Monday evening between 7-9pm, follow us on Facebook, or check us out on our website at www.hsfd. org. Have a great spring!

Medic Minute - Friday, April 15 is National Prescription Drug Take Back Day. According to the 2019 National Survey on Drug Use and Health, 9.7 million people misused prescription pain relievers, 4.9 million people misused prescription stimulants, and 5.9 million people misused prescription tranquilizers or sedatives. The survey also showed that a majority of misused prescription drugs were obtained from family and friends, often from the home medicine cabinet. The Take Back Day, which is sponsored by the DEA (Drug Enforcement Administration), provides an opportunity to prevent prescription drugs from falling

into the wrongs hands, and to help prevent drug addiction and overdose. According to Essence Healthcare, unneeded, unused, or expired medications should be safely disposed of as soon as possible, which is especially important for Controlled Substance medications to avoid accidental poisoning, misuse, or abuse. The U.S. DEA and its partners collect and safely dispose of medications as a service to communities nationwide, usually in April and October. Local pharmacies and law enforcement agencies are good sources of information for drug take back options. Here are two nearby locations to dispose of your medications: Highland Park CVS 126 South Buchanan St., Edwardsville IL 62025 & Walgreens 172E.McArthur, Bethalto, IL 62010. You can search online for additional locations at: https://www.fda.gov/drugs. For more information, go to https://www.fda.gov/consumers/consumer-updates/where-and-how-dispose-unused-medicines or https://www.deadiversion.usdoj.gov/drug_disposal/ takeback/. If a take back option is not available, two options of disposing medications at home are: 1) Flush the medication down a sink or toilet if the drug is on the FDA Flush List, which is available online at: https:// www.fda.gov/drugs/disposal--unused-medicineswhat-you-should-know/drug-disposal-fdas-flush-listcertain-medicines. 2) For drugs not on the FDA Flush List, follow these steps: A) Remove the drugs from their original containers and mix them with something undesirable such as used coffee grounds, dirt or kitty litter. Doing this makes the medication less appealing to children and pets and unrecognizable to



someone intentionally going through the trash. B) Put the mixture in something you can close, such as a re-sealable zipper storage bag, empty can, or other container with a lid, to prevent the drug from leaking or spilling. C) Scratch out all your personal information on the empty drug container and packaging to protect your identity and privacy, then throw it all into the trash.

Other options may be available for safe disposal of medications, such as disposal packets, and addressed envelopes for mailing. Slow Cooker Beef for Sandwiches

- 3 cups water
- 1 teaspoon black pepper
- 1 teaspoon dried basil
- 1 teaspoon dried parsley
- 1 bay leaf
- 1 (7 ounce) pkg dry Italian-style salad dressing mix
- 1 (5 pound) rump roast
- 1 teaspoon salt
- 1 teaspoon dried oregano
- 1 teaspoon onion salt
- 1 teaspoon onion salt
- 1 teaspoon garlic powder

Combine water with salt, ground black pepper, oregano, basil, onion salt, parsley, garlic powder, bay leaf and salad dressing mix in a saucepan. Stir well and bring to a boil. Place roast in slow cooker and pour salad dressing mixture over the meat.

Cover and cook on low for 10-12 hours, or High for 4 to 5 hours. When done, remove bay leaf and shred with a fork.

the bids for these, perhaps we can do part of Holiday Point Parkway, at least the worst part, since it's such a wide and long road. John Crotty Do we want to do more roads and get more roads done or do we want to get the big road done now and save those little roads for next year? **Tony Harris** I guess depends on if we think it's priority one. Anthony Harrell I think the little roads stick with the five-year plan and if we change it then we're going to be changing up that five-year plan and I'm for doing the residential roads, getting everybody's roads up to where they feel that they're acceptable. If we can fix the alligator stuff on Holiday Point Parkway and hold it back for a year and stick with our five-year plan, I'd like to do that. **John Crotty** Rob, do you feel like we can patch it up to make it last year? **Rob Clarkson** Yes. We can fix it with the patch machine, band-aid it and seal it next year. **Jerry Allen** I'm inclined to be disciplined about it and follow the fiveyear plan. **Rob Clarkson** If we stick with it, everybody's roads will be touched. Roads that hadn't been touched in 20 years we're touched the first go around and some of them were dirt. Robert Wittkamp I like option 1 with patching Holiday Point Parkway. I really agree you should stick with the five-year plan, that's why they came up with a five-year plan. The plans seem to be working. Holiday Point Parkway doesn't seem as bad shape where we have to deviate from the plan. I see no point in deviating from it. **Tony Harris** If we go with option 1 which would be fine, we're spending about \$68,000 based on last year's costs which we should expect to be higher. Do we want to approach this with having some backup roads to try to do more if we have the money or sounds like the we can't get much more than 25,000' of road in our one day of business anyway. So we may not be able to do that.

Reserve Funds to Be Spent 2022

I suspect it will be underfunded as well. Material list will be generated, and project postponed if we cannot meet the funding this year 3) 55K We would like to trade/sell off a 1 ton that is not set up to do the maintenance work and replace this vehicle. This will allow us to better use the equipment we have. 4) 30K Public Safety vehicle started to give us issues over the last year.

Reserve Investment Options

John Crotty Tony was going to present, but since he's not here and the person who sent the email, Mr. Decker is, maybe he'd like to review it for us. Dave Decker (1184) I ran across a federal government, I bond. It's a variable interest, federally backed bond and right now it's paying 7.12%. You can't find anything anywhere in a guaranteed investment that is paying that. Now the caveat to that is it was only paying that for six months. And the interest rate is adjusted every six months. And there's two components to the investment. One is the fixed rate and then the variable rate. The variable rate is based upon the current inflation rate. So basically, it's not an investment to, quote, make money, it's an investment to keep your moneys current value. So if you have money and you just leave it in the bank as inflation goes up, the value of that money continues to drop. This bond is designed to allow that money to keep track with inflation. Unfortunately, the interest was set in No-

vember. So I believe if I did my math right, in May, it'll be up for adjustment again. You don't know what that's going to be but if you were to invest it now, I think it's like \$50 a month you would make and you can only invest \$10,000 per year as a business. Other facts: •You can only buy \$10,000 of these per year. • They are exempt from State income tax (not a consideration for the association) •These are really just to keep up with inflation •You are required to keep them for a year before you can sell them. • If you sell prior to holding the bond for 5 years, you are penalized the last 3 months interest. • For the Association, these can only be purchased electronically. Currently, we've been trying to stagger CDs on a five-year ladder, where we buy \$100,00 per year, and we buy a five-year CD and then next year we buy another \$100,000 and currently the interest rates out there are like 2%, I don't know the current market. I haven't looked at it. But this was significantly higher. That's why I brought it to the finance committee's attention. I also reviewed it with Ray Garber and he's very big into CDs and investments and he felt it was a good solid investment, and he agreed with the recommendation that we should pursue it. The finance committee looked at it and the consensus from the finance committee was that we should go ahead and pursue it. So the recommendation is to take \$10,000 of the reserve monies that we have that are just either in CDs or sitting in the bank and buy this I bond. Then again next year, we'll look at it and see whether it's the right thing, and I personally, based upon what I'm seeing and how we do our CDs and our reserves, I believe that this is a good investment that we'll probably start doing on a regular basis and start buying \$10,000 a year in the future. For me, it's a no brainer, because I can't take that \$10,000, and for the next three months, make seven and a half interest rate on it. Shaun Diltz Right, now we don't have a couple years of CDs that we usually do because the interest is so low so this is something, better than nothing. And like Dave said, it's something that we could build upon year after year. Dave Decker (1184) And if we see that in the future we see that it's not paying us the interest rates we want, a) we can yank it out or b) we can leave what we have invested in there to continue to draw on what those rates are, I mean, it's not locking us down for definitely not a serious amount of money compared to \$500,000 that we have in the CDs. And the CDs are all under 2%, fiveyear CDs. One thing that you need to be aware of for sure is that it's bought electronically. so it has to be done through the computer, whether that's somebody in the office or whether the current treasurer does it, but it's all electronically. It's not paper bonds. You could do paper bonds, but I would highly recommend you don't do paper bonds. **John Crotty** Tony did mention that we have to get a contact for this. He recommended someone in the office, probably Rob since the board members rotates. His recommendation is that we would make Rob the contact for this. Shaun Diltz Makes a motion to purchase electronically \$10,000 of an I Bond and make Rob Clarkson the contact.

Restaurant Patio Expansion

John Crotty During the restaurant negotiations and contract, the board agreed at that time that we would provide \$10,000 to the restaurant to expand the patio out towards the lake on the flat area outside of the covered part of the patio. They have provided us a drawing that was included with your board packet. Jason Armbruster from the Foundry Boathouse is here to answer questions. Jason Armbruster That's a very loose drawing. That was the first one we did. We want to make it very organic; we don't want to make it square, but we don't know our parameters of how far you guys want us to go out or how far we can go out. Side to side is a little different, we're not going to go too far that way. But we just want to make sure that we all coincide together. I don't want to go too far out, obviously we're not going to go all the way down to the sand volleyball court, but we just want to make sure that the measurements are there. There is a gas line that will run out because we might have some fire tables there. We already have a gas line run out from the restaurant, but we just want to do run some conduit out underneath, everything is going to be underneath to not block the view or make it any worse than it already is. John Crotty What are these rectangular blocks on each side? Jason Armbruster Those are fire tables. **Robert Wittkamp** And the circle in the middle, is that another fire table? **Jason Armbruster** Yes, that's a fire pit that we want in there. This is just the first drawing of it, I kind of wanted to hear your opinions or concerns about whatever. It will be concrete or block, we haven't really decided vet. We built them at the other one, we built tall ones, we might make these short, we just don't really know yet. Robert Wittkamp I think I personally would like to see a photo of what you're planning. It might make it a little bit easier for us and maybe a little bit better of a drawing. Conversation ensues. Jerry Allen How many people to you think this will seat? **Jason Armbruster** 70 or 60, say 12 tables. It's more of a when we build it, and we see how many we can fit on it, but it won't be a 180-person patio or anything like that. And also at the end of that, we're going to put in astroturf and at least one bags game or bocce ball. Obviously, because we want to make it organic, wave instead of just flat, it might extend out another four foot. We don't want to take over more than what you think is viable. But the fire tables, we don't know if we want to do them yet, I just wanted to put them in so you could see kind of what we're thinking. I believe they're going to be shorter than what we have now. But I will give you pictures of what we have at the other one, but it'll probably be half that size. We're going to put in cooling concrete. It's stamped and its non-slip. We will have tables, umbrellas and we can shade it. But for the most part, we want it very user friendly. **Jerry Allen** I imagine you're open to having us down there on site and get an idea of what you wanting to do. Jason Armbruster Absolutely. You guys can be involved in the whole process. We're open for anything that anyone's uncomfortable with, or, you know, the whole process. We've had some people come out and look at it. Once I get a drawing from the people that we pick, I'll send it up to you guys. And if there's an issue, we're pretty easygoing, we're not headstrong on

But you know, you have the deck out there and stuff like that. But no, it's not anything that will benefit us more than just having more space. Robert Wittkamp So let's make that clear, that the understanding is this is an extension of the restaurant, not another deck or anything like we currently have, it is an extension of the restaurant. Jason Armbruster Yes. Jerry Allen I'm saying it'll be under your control as far as taking care of it. It shouldn't be used as any random person walking up and hanging out. It's part of the restaurant. Jason **Armbruster** Yes. And that's the only problem I foresee this summer, is people are going to come up and sit down when we have a wait or anything like that. We'll monitor all that. And we get it we'll handle it like we normally do. We don't really make anybody mad. So we'll figure it out. I always say growing pains. We're going to have growing pains with us being downstairs because it's obviously very busy. But this summer is going to be pretty crazy. **John Crotty** Sounds like everybody's good with this kind of footprint you have now, maybe with a little flexibility. Once you get someone out here to get a little more detailed plan, get a hold of the office and we can schedule to meet.

John Crotty It is specifically focused around the stop signs that were added last year at Caribbean Drive and Key Largo Terrace. They are requesting that they be removed. In summary, they feel they were unwarranted stop signs and they're just causing a nuisance and adding cost for unwanted stops. Ultimately they are asking the Board to correct the decision now that you have the facts and data that stop signs should be installed using an engineering study and not for speed purposes. There shouldn't be unwarranted stop signs at Caribbean and have consistency as our goal. **John Crotty** In 2020 or 2021, there was a correspondence for adding some stop signs in the neighborhood. There was a group, a subset of the board, Jerry was one of them and another previous board member that spent quite a bit of time looking at stop signs that we were going to put up throughout the neighborhood. We got feedback from Facebook and board meetings on this map. There was a board vote and it was approved to put stop signs out. We got a few of them installed before it was stopped because we had smaller stop signs going in some places and we chose as a board to not use the smaller stop signs any longer. And at that time, because we had not purchased any of the larger signs we decided to actually halt the progress and wait to see what the community feedback was on the stop signs that were put out there. At this time, we do obviously have a member that is asking to remove one of the stop signs that was put in. I know I've personally got feedback why some of the stop signs that were approved originally not been put in and I've have also suggested that those members come up to the board meeting and voice that opinion. Just a summary of where we were and how we got to the point why those stop sign are there. **Shaun Diltz** I've gotten negative feedback on people living on Caribbean & Fountainbleu on the stop signs that were added. I've mentioned to them to come up and voice that or send a correspondence. I don't know this person who said this, but it was nice to see community members doing their own research and literally putting the same IDOT & MUTCD studies I essentially said from the beginning to why these stop signs shouldn't have been put it. It's nice to see the community educating themselves. I completely agree with the correspondence. Jerry Allen I also got feedback too and it was positive and they wanted to know why the rest of them weren't put in. Shaun Diltz We stopped because the last conversation we had was there hasn't been one engineering study done on the 62 stop signs that are in the community already. I talked to Adam Walden, the county engineer, he said he will gladly show up here and talk to us about this, which he's going to be on the side of where I have been so if we want to further that, that sounds great to me. **Jerry Allen** Back to her letter, it says the unwarranted stop signs have had a negative effect on our community which is also supported by research. I'd like to see the negative effects she said she'd experienced. She's the only one who's complained or has reached out about the negative impact. And then again, going back to why it was put there was we had other board members monitor our community and sat on that road and saw a lot of people speeding down that road. Shaun Diltz Then they should have got a speeding ticket, not a stop sign ticket. **Jerry Allen** The whole point was to slow down the speeding on that road. **Shaun Diltz** And Jerry, it says in so many times in all this documentation, stop signs should not be used for speed control, ever, because they enhance the speeding from stop sign to stop sign. That's been proven and documented and written. So stop signs don't do anything for speed, they never have. John Crotty But we have not come up with any other way to do that, to reduce speed. Shaun Diltz We haven't talked about anything, we went right to stop signs. John Crotty The previous board went to stop signs. Shaun Diltz Without an engineering study. John **Crotty** As you mentioned, there's tons of stop signs in our neighborhood that has no engineering study. So unless we're suggesting take every stop sign out of the neighborhood. **Shaun Diltz** I would say that three quarters of them do not need to exist according to the IDOT parameters for stop signs. John Crotty But I don't think we're suggesting taking all the stop signs out of the neighborhood so I don't know how we can pick one or two to take out at this time. Conversation ensues. **Shaun Diltz** Well, it just shows the inconsistency. So I would make a motion but I know Tony's not here, he would be for me so I'll wait. Robert Wittkamp I would totally agree with the inconsistency. It is a problem. One thing I don't want to see us get into is to put stop signs up this board and take them out the next board. Shaun **Diltz** That's why I would like to have facts and data. **Ty Van Ryswyk** I agree with it. It needs to be looked into and done again correctly. I know there's people that don't want a stop sign at this intersection but for all the stop signs that went in at all these different intersections, and I'm not for it at all. But then you get people like I hope they don't put one at Nassau and Tampico, and that's the blindness one out here. In my opinion do I think it needs it? No, because I haven't seen a ton of accidents there. But I think it's weird that Caribbean, that's wide open and not a visual issue and I understand why they did it for speed, but again, had it been looked into that's been proven that that's not the reason to put a stop sign in. John Crotty This board decided last June, I would have to look to see when it exactly was that we would stop installing stop signs. If the membership came up and started asking for more stop signs, or I guess on the reverse side, people were complaining about the stop signs we would at that point make a decision if we wanted to invest in an engineering study for stop signs in our neighborhood. So we've had one comment to the board now since that time. I would hate to see us go start taking stop signs out without doing some sort of study. Do we warrant a study at this time? Shaun Diltz It feels like even if you get the studies done, and the people tell you, you still won't listen even though the numbers are there. Dave Decker (1184) You made a statement there that I want to challenge, that only one person has stated that they didn't want stop signs. One member, there were several members that came to the board meetings, myself included, who stated installing stop signs was a bad idea and didn't agree with them. I personally have had multiple people, I should say many, many people who have mentioned the one that is referenced tonight that they were definitely not in favor of it and don't agree with it. So there were several members who voiced their opinion against the idea. Since it was voted and approved, they haven't been back up and complained because they voiced their opinion at the time, but since you're requesting people to complain, just add me to the list. John Crotty What was some of the reasons for not wanting that stop sign there? Dave Decker (1184) They just felt it wasn't doing any good. Not to mention the number of people that they see running it. So that's just making it even more dangerous because you have folks that pull up to the opposing stop sign, who are expecting people to stop and they start to pull out and the other people don't. There is a state law that identifies on an intersection where there are no traffic control devices, stop signs, yield signs that determines who has the right of way. So if there was an accident, it's based upon that law. And there is no liability of not having a stop sign or a yield sign and an intersection. So that's the opinion that I've gotten from multiple people. And then others, you know, just to give full disclosures that others will be driving down that road and they just forget it's there. Because they've been here for 10-15 years driving down the road, and there wasn't one there. And then I'm going to make reference to the comment about Nassau and Tampico. Yes, that is definitely a blind spot but there's no traffic. And when people go down Tampico they slow down on that intersection because they take a look. I've lived out here 30 years, same spot, driven down that road when I was working every day, and in that entire time that I've lived out here if I've met a car on that intersection a dozen times. I'm probably overstating the number of times I've seen a car at that when I'm going down it. Robert Wittkamp I would like to get out of our opinions, all due respect. I would like to get out of our opinions and get into the facts. I want to deal with real numbers, not what this one person feels or this other person feels. That's my personal opinion. I just think that's the right way to go because if we're always going to be going back and forth, it's always going to be an issue. If we need to do a study on the most popular roads, the highest traffic, let's do that study and that study will cure everything else. We take every stop sign out, or whatever it is, it'll be off of the actual numbers, not off of anyone's personal feelings towards loving stop signs or hating stop signs, whatever they may. I suggest that we look further into doing the studies. Shaun Diltz I'll talk to Adam Walden tomorrow. Ty Van Ryswyk This letter brought that up tonight, I think we have to let that rest, we can't make a motion on it. We can't approve or deny it, but I think it's definitely brought something to our attention that we should move forward with. I'm not going to make a motion to take this stop sign out based on this letter. John Crotty Shaun you get some information on what it would take to get an engineering study. Shaun Diltz He offered his time to come here and pretty much discuss the same things that has already been done so I'll see what the next step is. As far as the what the warrants are we kind of went through it. It doesn't have over 300 units a day. Has there been more than two accidents in five years? The actual private way issues which I don't know what they fall under. **John Crotty** Give us an idea when you want it back on the agenda again to get into a little more.

2022 DECALS

As soon as your 2022 Dues & Assessments are paid in full you can come into the office & pick up your 2022 decals.
2021 Decals Expire April 30, 2022

Lot numbers and decals need to be present on ALL watercraft and slow moving vehicles.

This includes all non-motorized watercraft (kayaks, canoes, paddle-boards & paddle-boats). You must bring your current watercraft registration and proof of \$300,000 liability insurance on the watercraft to receive your motorized watercraft decal.

Slow Moving Vehicle decals are \$15 annually.

The state requires driver to have a valid driver's license and proof of minimum liability insurance coverage be carried within the vehicle.

PERSONAL FLOTATION DEVICES

PLEASE READ THE IMPORTANT INFORMATION BELOW REGARDING PERSONAL FLOTATION DEVICES. IT IS IMPERATIVE THAT THE APPROPRIATE PFD IS KEPT ON EACH WATER-CRAFT WHILE BOATING ON HOLIDAY LAKE AND SU TWAN LAKE. THIS INFORMATION CAN BE FOUND ON PAGES 9 AND 10 IN YOUR HOLIDAY SHORES BOATING RULES.

Personal Flotation Devices from 625 ILCS 45/4 1 No person may operate a watercraft unless at least one U.S. Coast Guard approved PFD of the following types or their equivalent is on board for each person: Type I, Type II or Type III. No person may operate a personal watercraft or specialty prop craft unless each person aboard is wearing a Type I, Type III or Type V PFD approved by the United States Coast Guard. No person may operate a watercraft 16 feet or more in length, except a canoe or kayak, unless at least one Type IV U.S. Coast Guard approved PFD or its equivalent is on board in addition to the PFD's required in paragraph A of this Section. A U.S. Coast Guard approved Type V personal flotation device may be carried in lieu of the Type I, II, III or IV personal flotation device required in this Section, if the Type V personal flotation device is approved for the activity in which it is being used. When assisting a person on water skis, aquaplane or similar device, there must be one U.S. Coast Guard approved PFD on board the watercraft for each person being assisted or towed. No person may operate a watercraft unless each device required by this Section is: Readily accessible; in serviceable condition; of the appropriate size for the person for whom it is intended; and legibly marked with the U.S. Coast Guard approval number. Approved personal flotation devices are defined as follows:

- Type I A Type I personal flotation device is an approved device designed to turn an unconscious person in the water from a face downward position to a vertical or slightly backward position and to have more than 20 pounds of buoyancy.
- Type II A Type II personal flotation device is an approved device designed to turn an unconscious person in the water from a face downward position to a vertical or slightly backward position and to have at least 15 1/2 pounds of buoyancy.
- Type III A Type III personal flotation device is an approved device designed to keep a conscious person in a vertical or slightly backward position and to have at least 15 1/2 pounds of buoyancy.
- Type IV A Type IV personal flotation device is an approved device designed to be thrown to a person in the water and not worn. It is designed to have at least 16 1/2 pounds of buoyancy.
- Type V A Type V personal flotation device is an approved device for restricted use and is acceptable only when used in the activity for which it is approved.

No person may operate a watercraft under 26 feet in length unless a Type II, Type III, or Type V personal flotation device is being properly worn by each person under the age of 13 on board the watercraft at all times in which the watercraft is underway; however, this requirement shall not apply to persons who are below decks or in totally enclosed cabin spaces. The provisions of this subsection I shall not apply to a person operating a watercraft on private property.

Further, no person may operate a watercraft on Holiday or Su Twan lakes unless a Type II, Type III, or Type V personal flotation device is being properly worn by each person under the age of 13 on board the watercraft at all times in which the watercraft is underway.


